Billy Te Kahika is the first Politician to qualify the Crown of the Mauri Nation as a Suv'eran Government in his live broadcast on Facebook uploaded on 2nd February 2021 [subsequently deleted since]

This historic event qualified "*Lady-Crown*" is a Suv'eran Queen. "*Tumuaki*" means Crown of the Head, Leader.
