That notwithstanding that the Resolution regarding our Te Wakaminenga o Nga Tino Rangitira o Nga Hapu o Aotearoa Declaration Order was passed on the 14th December 2020; as since the 13th December 2020 Resolution that was passed in the Wharenui by “Ko Matou ko ngaa tino Rangatira” (separate jurisdiction to the unconstitutional KOTAHITANGA ADMIN’s Hui) where Reuben in the Wharenui moved his second Motion for myself to Spearhead this Declaration Order, where such claims that certain conditions attached to this as alleged by Cliff and Reuben were inventions rather that were never found by them in the Minutes; therefore what actually disturbed me was that I had invited only a certain amount of people to help work with me regarding what transpired on the Friday, 11th December 2020. The reason being is because:

I was also told that Michael Stace was looking for me; so when this instruction came from a member of the KOTAHITANGA ADMIN, this implied that they asked myself to make contact with Michael Stace, that he would fill me in as to what the matter in hand was, for myself to address. This was my first ever contact with Michael Stace.

So clearly, this matter that I was asked by the KOTAHITANGA ADMIN to assist with and accommodate Michael Stace, was never a NZPP matter concerning you Billy Te Kahika. As I mentioned, once I had read the SPECIAL RESOLUTION on the Saturday morning that was passed on the Friday 11th December 2020 as the initial concern, then when Michael and Alistair Wait briefed me as to what the second concern was, and I saw the seriousness of this matter, that Saturday morning I invited both Michael and Alistair over to my Motel across the road, so that we can get on Internet, on our Laptops and start drafting up the documentation forthwith. Out of courtesy I had invited you Billy, as well as Georgi since she is my Joint-Head of State representative for “Te Hapuu O Te Wakaminenga Waahi O Maniapoto”. Alistair’s partner Caroline came too, and so did Michelle Hood. That Dot tagged along with Alistair; she wasn’t really invited by me to attend. Tiahine turned up too I recall. This Declaration Order now became a Wakaminenga The Confederation Of Chiefs Of The United Tribes Of Aotearoa, MAORI GOVERNMENT OF AOTEAROA matter of National Importance, and outside of Georgi Job’s jurisdiction, since she has never been appointed by the National Wakaminenga Council to represent our Sovereign Government.

That from the The Minutes given to me on that Saturday morning, clearly shows that:

- (1) A Special Meeting was called by a group of people on the Friday, 11th December 2020, who presented a “taake” to the Forum Tent KOTAHITANGA ADMIN at 9pm, which ended at 9:36pm;
- (2) **Reuben Heihe** moved the Resolution on behalf in regards to (1) it was a breach against the Te Tiriti o Waitangi 6th February 1840;

What actually took place during the afternoon, after the Powhiri, of the 11th December 2020 I was told, was Alistair, his partner Caroline and Harley in one car, and Michael in another car, were heading to Auckland Airport, to pick up **Lady-Crown: Turikatuku III**. Passports-[a]ct-1992-Sect-2: = “certificate-of-[i]identity” a document, other than a passport, issued by the government of any country to any man/woman for the purposes of facilitating his or her entry into or exit from any country.

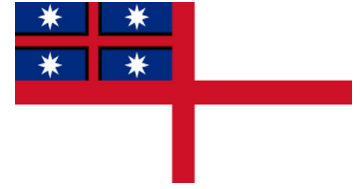

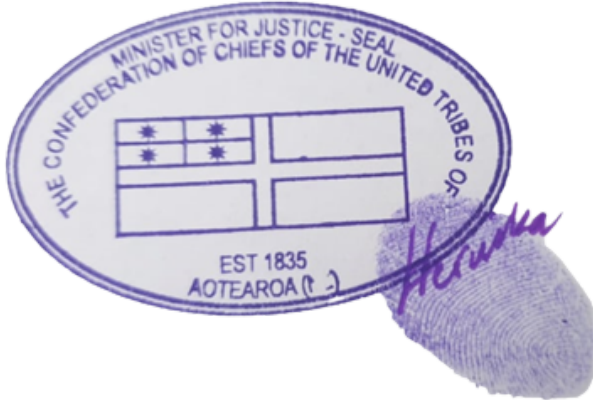

Te Wakaminenga o Nga Tino Rangitira o Nga Hapu o Aotearoa Nu Tireni 1835 under the Divine Authority of Io Matua te Kore Declaration of 13 December 2020

The following declaration is made on behalf of those who attended He Wakaminenga o Aotearoa assembled at Waitangi and those sovereign people present;

Ko matou ko nga Tino Rangitira o nga iwi me nga hapu o Hawaikitahutahu, kua oti nei te huihui i Waitangi; ka whakauu ano i te w(h)akaputanga i te Rangatiratanga me te Mana Motuhake o to matou whenua;

We, the absolute leaders of the tribes and societies of Hawaiki-tahutahu, having assembled at Waitangi, do hereby reaffirm the declaration of the authority and leadership of our country;

The original Chiefs of the Northern Tribes of Hauraki were the ones who signed the Declaration of Independence 1835 written Constitution; This action followed the gifting of the Kara Tuatahi at Portsmouth, England, by King William IV to the thirteen Mauri Chiefs on 22 October 1832;

He Wakaputanga 1835 is our written constitution made by the Chiefs of Hapu and affirmed by King William IV, his Parliament, and further ratified by a 21-gun salute from HMS Alligator, and is recognized as standing to this day; That 1835 Constitution is the authority by which Rangatira autographed Te Tiriti o Waitangi 1840, where the latter conferred its constitutionally-granted powers from the former;

The 20th of March 1834 Constitutional flag (portrayed at the top of this page) is the first national flag of this land. It remains the only lawful flag to this day;

It must be noted that the Wakaminenga Kohuiarau was founded on the 17th August 1808 at Okoroire, as a single-hulled waka;

The following has come to the attention of the assembly:

- The Treaty Partner, identified as the Crown of England, vacated their obligations and position under Te Tiriti o Waitangi with the unlawful adoption of the HER MAJESTY THE QUEEN IN RIGHT OF NEW ZEALAND corporation in 1986, with the assent of the New Zealand Constitution Act 1986 on 13 December 1986;
- Te Tiriti o Waitangi expired at midnight on the death of Queen Victoria, 22 January 1901, due to the fact that the articles of Te Tiriti o Waitangi as well as the Treaty of Waitangi Act 1975 make no provision for the obligation of the monarch's lawful heirs and successors;
- Pacific Islanders Protection Act 1875, s7. Saving of Rights of Tribes:
"Nothing herein or in any such Order in Council contained shall extend or be construed to extend to invest Her Majesty, her heirs and successors with any claim or title whatsoever to dominion or sovereignty over any such islands or places as aforesaid, or to derogate from the rights of the tribes or people inhabiting such islands or places, or of chiefs or rulers thereof, to such sovereignty or dominion..."

- Using Part 1, Section 5 of the New Zealand Constitution Act 1986 titled "Demise of the Crown", there was an unlawful attempt at transference of authority from the Crown of England to a corporate entity registered with the Securities and Exchange Commission (SEC) in Washington, D.C., United States; registered as HER MAJESTY THE QUEEN IN RIGHT OF NEW ZEALAND, SEC.gov CIK #0000216105;

Gregory Baughen: "Ah, that doesn't apply in New Zealand, as we do not have an established religion." *

* The Queen of the UK is the Defender of the Faith. If HER MAJESTY THE QUEEN IN RIGHT OF NEW ZEALAND is not the Defender of the Faith, she is also not the queen.

WHEREAS: Coronation Oath Act 1689. Authorized King James Bible, LICENCE, "In terms of the Letters Patent granted by Her late Majesty Queen Victoria to Her Printers for Scotland, and of the Instructions issued by Her said Majesty in Council, dated 11th July 1839, ... " authorized WILLIAM COLLINS SONS AND COMPANY LIMITED, 144 Cathedral Street, Glasgow, to print and publish, as by the authority of Her Majesty Queen Elizabeth II, ... Declaration dated the 27th day of September 1957, ... Dated at London the 30th day of October 1957." W.R. MILLIGAN, Lord Advocate.

Section 6: Power to make subordinate legislation under imperial enactments part of laws of New Zealand (2) ..., no Imperial subordinate legislation made after the commencement of this Act shall have effect as part of the laws of New Zealand;

This Act does not speak about the Laws of Nu Tirenī in *rem*. It mentions the laws of New Zealand in *personam*. As "...a phrase in a statute cannot call what is non-existent into being." Yet, it does say that, "no Imperial subordinate legislation made after the commencement of this Act shall have effect as part of the laws of New Zealand."
