Whereas by LETTERS PATENT 2018 under the Great Seals of **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana**, Our Ariki Hongi Hika and Turikatuku II, Our Arikini Lady Crown Turikatuku III **authorise and empower** Our Paremata Sovereign Nation State and Embassy, Gondwana Land and a Government of Paremata Sovereign Nation State and Embassy, Gondwana Land.

Whereas by LETTERS PATENT 2018 under the Great Seals of **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana**, Our Ariki Hongi Hika and Turikatuku II, Our Arikiniui Lady Crown Turikatuku I'll execute **all the rights, powers, privileges and authorities** to Our Paremata Sovereign Nation State and Embassy, Gondwana Land and a Government of Paremata Sovereign Nation State and Embassy, Gondwana Land.

Whereas by LETTERS PATENT 2018 under the Great Seals of **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana**, Our Ariki Hongi Hika and Turikatuku II, Our Arikiniui Lady Crown Turikatuku I'll **instruct the provision for the publication and the coming into operation and the coming into force** of the said LETTERS PATENT 2018 bearing the date this LETTERS PATENT 2018 is autographed and witnessed by a Notary Public and by Sovereign Queen 'Ariki' Turikatuku III.

Whereas by LETTERS PATENT 2018 under the Great Seals of **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana**, Our Ariki Hongi Hika and Turikatuku II, Our Arikiniui Lady Crown Turikatuku I'll execute **all rights, powers, privileges and authorities of Tino Rangatiratanga** meaning '**absolute sovereignty**', '**the spiritual reign or authority of God**' and '**God's inheritance to Maori**'. It is not negotiable, saleable, transferable or tradable. It remains intact in all its nuances and intricacies, meanings and customs. It remains forever unchangeable why, because I say it is, from my tupuna who lived it, to myself who breaths it. The following Maori verse describes the versatility of the meaning of Rangatiratanga using various bible translations of the same text. In Numbers 24:19; *A ka whai Rangatiratanga tetahi e puta mai i roto i a Hakopa, a ka huna e ia nga morehu o te pa.* – Rangatiratanga is translated as rule; the king of Israel will rule and destroy the survivors of every town there (Contemporary English Version). In the Modern King James (MKJV1962): Rangatiratanga is translated as kingdom, dominion, authority; Out of Jacob shall come he who shall have dominion and shall destroy him who remains in the city. and; In the New English Translation (NET): Rangatiratanga is translated as ruler; A ruler will be established from Jacob; he/she will destroy the remains of the city. Other common biblical translations are; kingdom, dominion, authority, rule, ruler, Excellency, dignity, prosperity. Obviously, we are confronted by what I consider a more accurate understanding of what my tupuna believed in their hearts and minds when they signed Te Tiriti o Waitangi.

Whereas by LETTERS PATENT 2018 under the Great Seals of **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana**, Our Ariki Hongi Hika and Turikatuku II, Our Arikiniui Lady Crown Turikatuku I'll **revoke** All Letters Patent from 1769 to the present day, any derivatives and derivations of Letters Patent and the said instructions of Queen Victoria and King George VI and Elizabeth R, Queen Elizabeth the Second and her heirs and her successors, including but not limited to; all rights, powers, privileges, authorities, appointments and officers thereof, thereto and therein, without prejudice, appurtenant to the PARRAMATTA CITY COUNCIL being a registered CORPORATION ABN 49907474773 including but not limited to PARRAMATTA CITY COUNCIL its CEO, Lord Mayor, its Directors, it's Agents, it's Officers, its Public Servants *hereafter now known in its entirety, as a united body PCC INC*, including but not limited to HON MALCOM TURNBULL, CABINET MINISTERS/DIRECTORS/TRUSTEES, and the Crown of the Australian Government any and all derivatives and derivations of this legal fiction Corporation, names, persons and members *hereafter now known in its entirety, as a united body AUST GOV INC*, **are hereby revoked** within the **Our REALMS and TERRITORIES OF OUR PAREMATA SOVEREIGN NATION STATE AND EMBASSY, GONDWANA LAND, AUSTRALIA** by the coming into force of these Our Letters Patent 2018.

Whereas by LETTERS PATENT 2018 under the Great Seals of **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana**, Our Ariki Hongi Hika and Turikatuku II, Our Arikiniui Lady Crown Turikatuku III **constitute, announce and declare** that **Our REALM AND TERRITORIES OF OUR PAREMATA SOVEREIGN NATION STATE AND EMBASSY, GONDWANA LAND, AUSTRALIA** which comprises of, but is not limited to;

- a. Rangihou Lands - 114 Acres (Parramatta River, Morton Street, Victoria Road, Wilde Ave) encompassing Rangihou Sacred Burial Site (Parramatta River, New Zealand Street, Rangihou Crescent, Thomas Street, Morton Street), all lands above and below; and
- b. Baludarri Sacred Burial Site and Wetlands 2.3 hectares (Parramatta River, Morton Street, Thomas Street, James Ruse) , all lands above and below; and
- c. Parramatta City Council, Gondwana Land, Australia including but not limited to Arthur Phillip Ward, Caroline Chisholm Ward, Woodville Ward, Elizabeth Macarthur Ward, Lachlan Macquarie Ward, Carlingford Ward, The Hills Ward, Epping Ward and Auburn Ward; and all that abuts these lands in accord and satisfaction with those additional lands claimed and /or in the process of being claimed through the Creditors Statutory Demand Ref:pbrsvsd0003 8th August 2018 and LETTERS PATENT 2018, all lands above and below; and
- d. All council lands leading to the Balmain Maori Rock Carvings at Callan Park, both sides of the river, including Rodd Island, lands up to Victoria Road; and
- e. Self-governing state of Paremata Sovereign Nation State; and
- f. Sovereign Queen Arikiniui Lady Crown Turikatuku III who shall be Our Head of State in Our Realm of Paremata Sovereign Nation State and shall have and may exercise the powers and authorities conferred to them by these Our Letters Patent, but without prejudice to the office, powers or authorities of any other individual who has been appointed to represent Us in any part of Our Realm of Paremata Sovereign Nation State; and
- g. Hereafter now known in its entirety, as a united body of land **REALM PSNS INC**;

And Whereas We, **Sovereign Queen 'Ariki' Turikatuku II** born 1759 - 1827 daughter of Mutunga II and Te Koki, was the wife of Ariki Hongi Hika Ngapua 1770 - 1828, son of Te Hotete and Tuhikura, descended from Rahiri from Puhi-moana-Ariki of Ngapuhi and Whakaruru and Ahuati. Turikatuku II was the kaitiaki [guardian] of the sacred relic taonga 'the jaw bone' of Giant Ariki Mahia and she was a spiritually gifted visionary who could move nature with her voice. She bears the sacred mark of 'War Tohunga' War Chieftainess with high ranking authority, every family line connecting to the 'Ariki' War Chiefs, Ariki of the North and back to the home of Kupe. Her husband 'Ariki' Hongi Hika, he was the first Ariki Māori King to be invited to meet King George IV in 1820, thereafter initiating Aotearoa, New Zealand's founding document with King William IV, He Wakaputanga o te Rangatiratanga o Nu Tireni 1835 (Declaration of Independence 1835) and Te Tiriti O Waitangi 1840 (Treaty of Waitangi 1840).

And Whereas We, **Sovereign Queen 'Ariki' Turikatuku III** born 1970, born of Ariki Hongi Hika and Turikatuku II, messenger brought forward, The Seal of Covenant from 'IO Matua Kore' [Supreme God], anointed and validated by spirit, *put forward her voice*; for she stands at the top of high places by the way in the places of the paths. IO Matua Kore possessed her in the beginning of his way, before his works of old; set up from everlasting, from the beginning or ever the earth was; before the mountains were settled; before the hills was *she brought forth*. When IO Matua Kore prepared the heavens, *she was there*; when he set a compass upon the face of the earth, when he established the clouds above, when he strengthened the fountains of the deep, when he gave to the sea his decree, that the waters should not pass his commandment, when he appointed the foundations of the earth, *she was by him*, as

one brought up with him; and *she was daily his delight*, rejoicing always before him. Her delights were with the sons of men. Turikatuku III the voice; *"To you O people, I call out; I raise my voice to all mankind; "You who are simple, gain prudence; you who are foolish, set your hearts on it; for I speak of excellent things, and the opening of my sacred lips shall be right things; the words of my mouth shall speak truth and wickedness is an abomination to my lips; all the words of my mouth are righteousness, there is nothing froward or perverse in them; they are all plain to him that understand, and right to them that find knowledge."*For she cries at the highest point along the way, where the paths meet, she takes her stand; beside the gate leading in the city at the entrance, at the coming in at the doors; the Counsel is hers and sound wisdom; by her Kings Reign and Princess decree justice. *She leads the way of righteousness* in the midst of the paths of judgement; for *she speaks of excellent things*, for the *opening of her lips shall be right things*. Receive her instruction and not silver; and knowledge rather than gold, for wisdom is better than rubies; and all the things that may be desired are not to be compared to it. Riches and honour are with her, durable riches and righteousness, *her fruit is better than gold and her revenue than choice silver*. Her wisdom dwells with prudence and she finds out knowledge of witty inventions. The fear of IO Matua Kore is to hate evil, pride, arrogancy and the evil way, and the froward mouth she does hate. She leads in the way of righteousness in the midst of the paths of judgment and those that love her inherit substance and she will fill their treasures. Blessed are the men that hear her, watching daily at her gates, waiting for the posts of her doors. O men, she calls; and her voice is to the sons of man; hear her instruction, and be wise; for whoso findeth her, findeth life, and shall obtain favour of IO Matua Kore; *but refuse it not for he that sinneth against her, wrongeth his own soul; and all they that hate her, love death*. By IO Matua Kore's Authority, She is Authority. By IO Matua Kore's Seal, She is sealed. By Io Matua Kore's laws, She is free. She is Sovereign.....

*"Tarure kit e taha ko Turikatuku ko te wahine taki wairua",
"Languishing listlessly to the side is Turikatuku, The Spirit Challenging Woman."*

And Whereas, We Sovereign Queen Arikinui Lady Crown Turikatuku III **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana** are **non-adverse, non-belligerent, non-combatant, and non-contentious**, by the Grace of IO Matua, in Our collective capacity, Sovereign Monarchs and Sovereign Head of State of Paremata Sovereign Nation State and Embassy Gondwana Land Australia, Defender of the Faith.

Recites He W(h)akaputanga o te Rangatiratanga o Nu Tirenī 1835(Declaration of Independence 1835) or 'the creation of the dominion or kingdom of New Zealand'. Whereas by the appointed hands of Henry Williams, Missionary, C.M.S. George Clarke, C.M.S. James C. Clendon, Merchant. Gilbert Mair, Merchant signatories on behalf of His Most Gracious Majesty the King of England bearing date of 28th October 1835 declared the Independence of New Zealand constituted and declared an Independent State; All sovereign power and authority declared to reside entirely and exclusively in the hereditary chiefs; also declared they will not permit any legislative authority separate from themselves to exist, nor any function of government to be exercised unless appointed by them; and to thank His Majesty, the King of England for the acknowledgement of our flag [The United Tribes Flag] and thank him for being the protector from all attempts upon its independence.

Ko matou ko nga tino Rangatira ka mea nei kia huihui ki te runanga ki Waitangi a te Ngahuru i tenei tau i tenei tau ki te wakarite ture kia tika ai te wakawakanga, kia mau pu te rongo kia mutu te he kia tika te hokohoko, a ka mea hoki ki nga tauwi o runga, kia wakareea te wawai, kia mahara ai ki te wakaoranga o to matou wenua, a kia uru ratou ki te wakaminenga o Nu Tireni.

Ka mea matou kia tuhituhia he pukapuka ki te ritenga o tenei o to matou wakuputanga nei ki te Kingi o Ingarani hei kawe atu i to matou aroha nana hoki i wakaae ki te Kara mo matou. A no te mea ka atawai matou, ka tiaki i nga pakeha e noho nei i uta, e rere mai ana ki te hokohoko, koia ka mea ai matou ki te Kingi kia waiho hei matua ki a matou i to matou Tamarikitanga kei wakakahoretia to matou Rangatiratanga.

KUA WAKAAETIA katoatia e matou i tenei ra i te 28 Oketopa, 1835, ki te aroaro o te Reireneti o te Kingi o Ingarani.

English Translation

Declaration of Independence of New Zealand 1835

We, the hereditary chiefs and heads of the tribes of the Northern parts of New Zealand, being assembled at Waitangi, in the Bay of Islands, on this 28th day of October, 1835, declare the Independence of our country, which is hereby constituted and declared to be an Independent State, under the designation of The United Tribes of New Zealand.

All sovereign power and authority within the territories of the United Tribes of New Zealand is hereby declared to reside entirely and exclusively in the hereditary chiefs and heads of tribes in their collective capacity, who also declare that they will not permit any legislative authority separate from themselves in their collective capacity to exist, nor any function of government to be exercised within the said territories, unless by persons appointed by them, and acting under the authority of laws regularly enacted by them in Congress assembled.

The hereditary chiefs and heads of tribes agree to meet in Congress at Waitangi in the autumn of each year, for the purpose of framing laws for the dispensation of justice, the preservation of peace and good order, and the regulation of trade; and they cordially invite the Southern tribes to lay aside their private animosities and to consult the safety and welfare of our common country, by joining the Confederation of the United Tribes.

They also agree to send a copy of this Declaration to His Majesty, the King of England, to thank him for his acknowledgement of their flag; and in return for the friendship and protection they have shown, and are prepared to show, to such of his subjects as have settled in their country, or resorted to its shores for the purposes of trade, they entreat that he will continue to be the parent of their infant State, and that he will become its Protector from all attempts upon its independence.

Agreed to unanimously on this 28 day of October, 1835, in the presence of His Britannic Majesty's Resident.

(Here follows the signatures or marks of thirty-five Hereditary chiefs or Heads of tribes, which form a fair representation of the tribes of New Zealand from the North Cape to the latitude of the River Thames.) English witnesses: (Signed) Henry Williams, Missionary, C.M.S. George Clarke, C.M.S. James C. Clendon, Merchant. Gilbert Mair, Merchant.

I certify that the above is a correct copy of the Declaration of the Chiefs, according to the translation of Missionaries who have resided ten years and upwards in the country; and it is transmitted to His Most Gracious Majesty the King of England, at the unanimous request of the chiefs. (Signed) JAMES BUSBY, British Resident at New Zealand.

Recites Te Tiriti O Waitangi 1840 (Treaty of Waitangi 1840).

Whereas by the appointed hands The Queen, Mr W HOBSON Lieutenant Governor, The Queen of England agreed to protect Maori and their way of life, preserved to Māori their independence, absolute sovereignty, power and control of their land herein this peace treaty. The agreement is to make a government for her people who are now in New Zealand and for those who will come in the future.

First: Māori give to the Queen of England the right to have a governor in New Zealand. **Second:** The Queen agrees that Māori keep their independence and keep control, full rangatiratanga [absolute sovereignty] of their lands, their villages and all their possessions, treasures. They give to the Queen the right to buy land, if they want to sell it.

Third: The Queen gives Māori people the same rights as British people. **Fourth Spoken promise:** The Governor promises to protect Māori customs and the different religions in New Zealand. **Whereas** signed by 512 Māori Chiefs; Recognised in International Law; and this treaty maintains Māori Authority in Aotearoa, New Zealand. **Let it be known** that Māori far outnumbered the European and were in control of the whole country. **Let it be known** that Māori did not give their sovereignty to the Queen;

English Translation

Treaty of Waitangi 1840

Victoria, the Queen of England, in her kind (gracious) thoughtfulness to the Rangatira and Hapū of New Zealand, and her desire to preserve to them their Rangatiratanga and their land, and that peace and quietness may be kept with them, because a great number of the people of her tribe have settled in this country, and (more) will come, has thought it right to send an officer as one who will make a statement to (negotiate with) Māori people of New Zealand. Let the Māori Rangatira accept the governorship (Kawanatanga) of the Queen over all parts of this country and the Islands. Now, the Queen desires to arrange the governorship lest evils should come to the Māori people and the Europeans who are living here without law. Now, the Queen has been pleased to send me, William Hobson, a Captain in the Royal Navy to be Governor for all places of New Zealand which are now given up or which shall be given up to the Queen. And she says to the Rangatira of the Confederation of the Hapū of New Zealand and the other Rangatira, these are the laws spoken of.

This is the first - The Rangatira of the Confederation and all the Rangatira who have not joined that confederation give absolutely to the Queen of England for ever all the Governorship (Kawanatanga) of their lands.

This is the second - The Queen of England agrees and consents (to give) to the Rangatira, hapū, and all the people of New Zealand the full rangatiratanga of their lands, their villages and all their possessions (taonga; everything that is held precious) but the Rangatira give to the Queen the purchasing of those pieces of land which the owner is willing to sell, subject to the arranging of payment which will be agreed to by them and the purchaser who will be appointed by the Queen for the purpose of buying for her.

This is the third - This is the arrangement for the consent to the governorship of the Queen. The Queen will protect all the Māori people of New Zealand, and give them all the same rights as those of the people of England.

W HOBSON Lieutenant Governor.

Spoken Promise - The Governor says that the several faiths (beliefs) of England, of the Wesleyans, of Rome, and also Māori custom shall alike be protected by him.

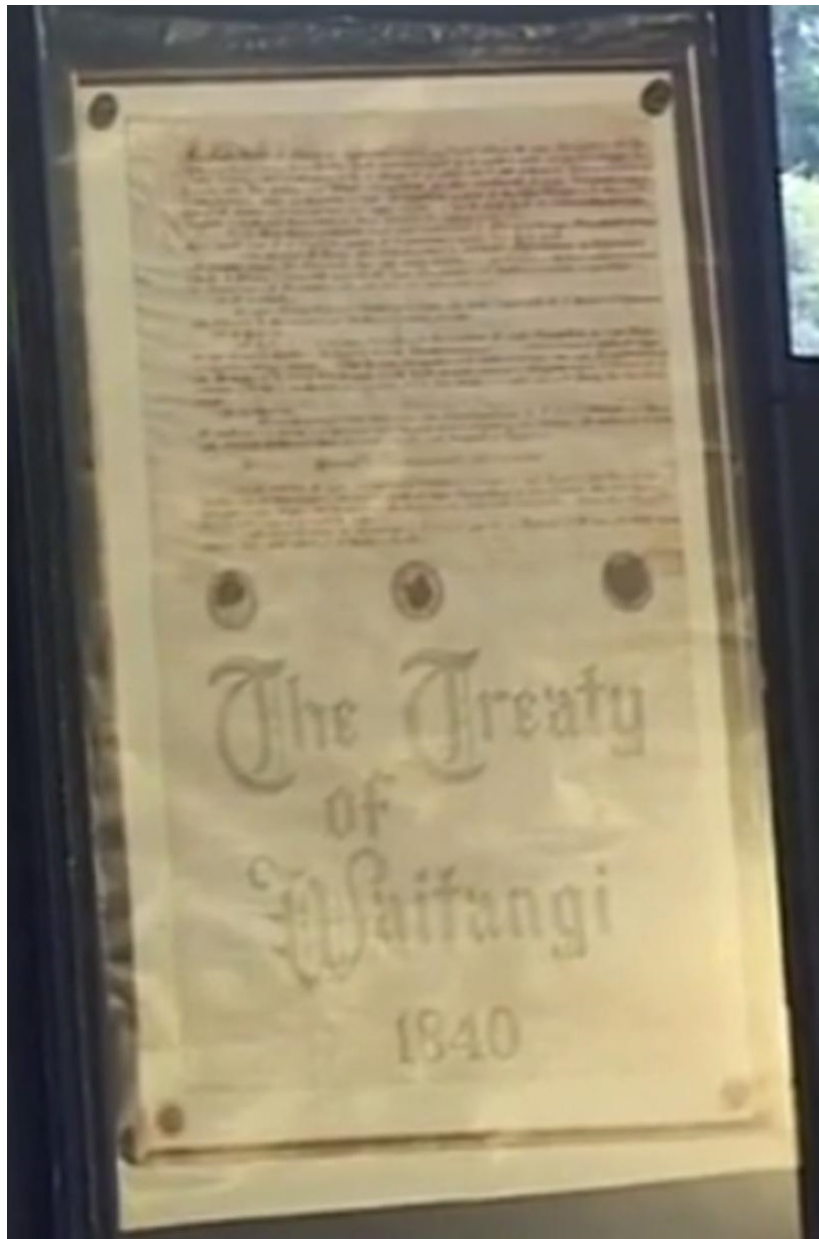

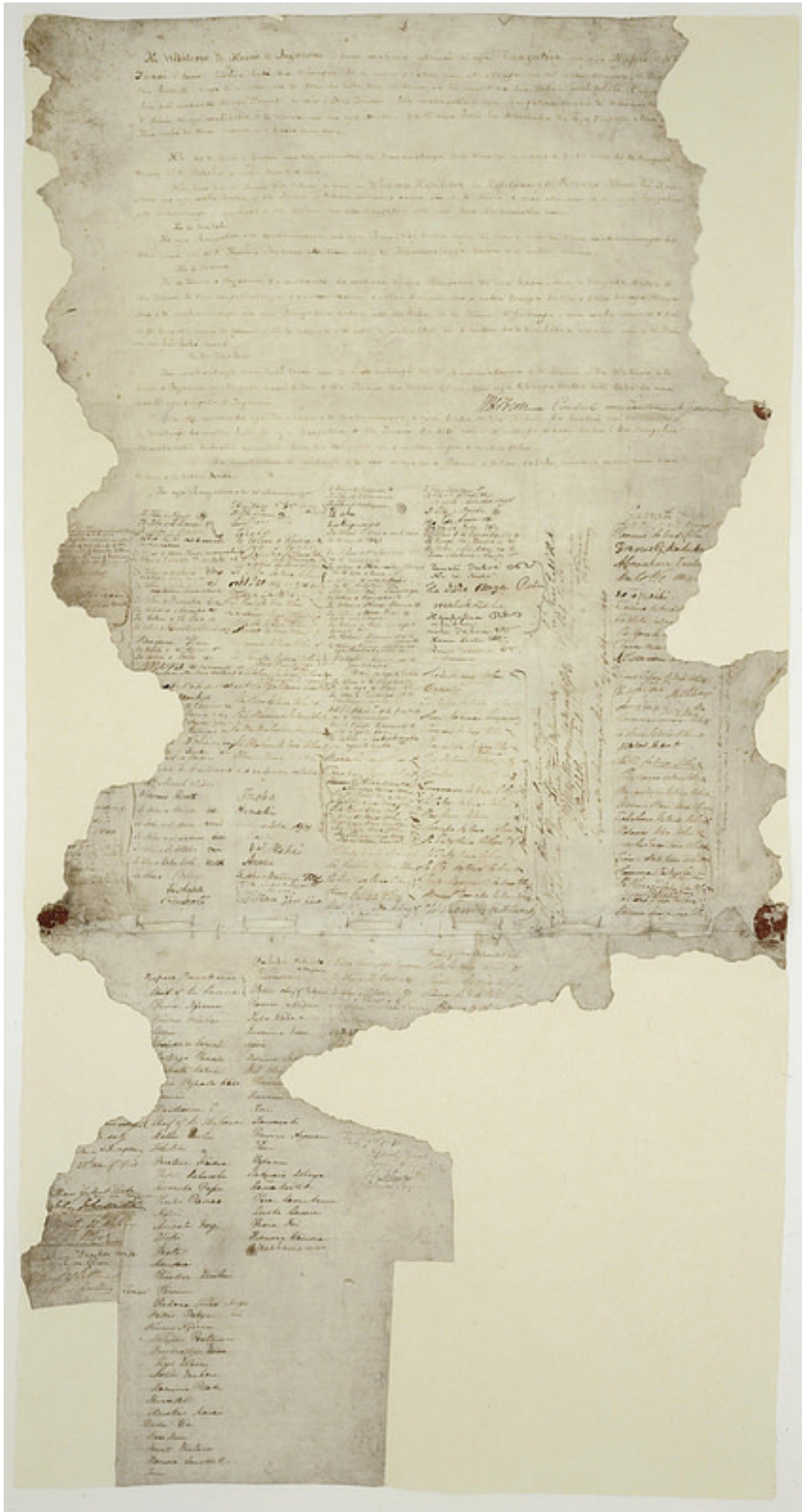

And Whereas, **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana Recites the Crown Protectorates and Common Law Doctrine:**

1. **Magna Carta, Section 39;** *"No freeman shall be arrested or imprisoned or deprived of his freehold or outlawed or banished or in any way ruined, nor will we take or order action against him, except by the lawful judgment of his equals and according to the law of the land."*
2. **Standing Order; 1836 The British Crowns Feudal Protectorate** *"Affording to those Chiefs such support and protection as may be consistent with a due regard to the Just rights of Others."*
3. **Standing Order; 1839 The British Crowns Fiducial Title** *"duties of good faith and confidence and must exercise a very high standard of care in managing our Māori lands, resources, estates and funds. Enforced by Letters Patent issued by Lord Normanby."*
4. **Standing Orders; 1839 Instructions from Lord Normanby** *"title to the soil and to the Sovereignty of New Zealand is indisputable, and has been solemnly recognised by the British Government; I have already stated that we acknowledge New Zealand as a Sovereign and independent State..., is binding on the faith of the British Crown; It is further necessary that the Chiefs should be induced, if possible, to contract with you, as representing Her Majesty that henceforward no Lands shall be Ceded either gratuitously or otherwise, except to the Crown of Great Britain; All dealings with the Aborigines for their lands must be conducted on the same principles of sincerity, justice and good faith as must govern your transactions with them for the recognition of Her Majesty's Sovereignty in the Islands. Nor is this all. They must not be permitted to enter into any contracts in which they might be the ignorant and unintentional authors of injuries to themselves."*
5. **Te Ture Whenua Māori Land Act 1993;** The Act may be cited as the Maori Land Act 1993. Native title covers all land, natural and physical resources under Te Tiriti o Waitangi (Treaty of Waitangi) 1840. The fisheries issue covers Customary Law and the Native Title, where it has not been extinguished. He Whakaputanga o Te Rangatira o Nga Un o Nu Tireni (1835 Declaration of Independence) is still alive today, and it currently exists Under Part XIII of Te Ture Whenua Maori, Maori Land Act 1993.
6. **New Zealand Constitution Act (United Kingdom) 1846 section 10;** *"Māori Customary laws were to be made by Māori self Governments, Governments in their own native districts, and if they wanted their laws recognised internationally, they could do this through the Queen who issued letters patent more or less acknowledging receipt of those laws, and she place them into the law of England right around the Common Wealth of the United Kingdom (UK) and enforces them back."*
7. **1846 Royal Charter and Instructions, chapter xiv;***"In cases arising between the native inhabitants of the same problem alone, the Courts and Magistrates shall uphold Māori customary usages, laws and customs aforesaid."*
8. **1852 New Zealand Constitution Act Section 71,** Provisions as to Māori Laws and customs - And whereas it may be expedient that laws, customs and usages of the aboriginal or Native inhabitants of New Zealand so far as they are not repugnant to the general principles of humanity, should for the present be maintained for the government of themselves in all relations to and dealings with each other, and that particular districts should be set apart within which such laws, customs, or usages should be so observed. It shall be lawful for Her Majesty, by any letters patent to be issued under the Great Seal of the United Kingdom, from time to time to make provisions for the purposes aforesaid, any repugnancy of any such Native laws, customs, or usages to the law of England or to any law, statute or usage in force in New Zealand, or in any part thereof an anywise notwithstanding.
32. **1872 Pacific Islander Protection Act,** with the royal assent of Queen Victoria, officially

recognised the sovereignty of Aboriginal Nations and Peoples. In doing this, the British parliament included in the legislation the recognition of the authority of our chiefs (Law/Lore men and Law/Lore women) by legislating that their powers and authorities could not be diminished in any way whatsoever. "Aboriginal Sovereignty is no longer a dream. Sovereignty is not only a fact but a matter of law as written in the Pacific Islanders Act of 1875." In the final part of the 1875 Pacific Islanders Protection legislation, it was a requirement of the parliaments of each of the colonies identified that these Orders in Council were to be tabled in each House of Parliament. Section 6 of the Pacific Islander Protection Act 1872-75 clearly limits the purported jurisdiction of the UK Parliament and its' monarch to British Subjects ONLY.

33. **Halsbury's Statutes 3rd edition, Volume 36 - Statutes, paragraph 559 page 337 paragraph 12, 12(1);** *"the Sovereignty of the parliament of the Original Tribes could not be usurped by the Sovereignty of the Parliament of the UK. This rule applies equally for Pacific jurisdictions."*559. Legislative supremacy of Parliament-The legislative authority of the Sovereign in Parliament is supreme (e), A statute, whether public or private (f), can define or override the common law (g), abrogate local custom (h) and amend or repeal the provision of earlier statutes (i). Since, however, every Parliament is supreme, one Parliament cannot derogate from the powers of a subsequent Parliament (k), and it follows that a statute can neither provide that it shall be incapable of repeal (l) nor dictate the form of subsequent legislation (m)'. 12.1 As can be found in (i) of above, [para. 12], New Zealand Parliament cannot derogate from the Sovereign Supremacy of England and England cannot derogate from the Sovereign Supremacy of The Māori Nation assembled in Parliament at Waitangi and following the principle found in (k) a statute does not need to state that it cannot be repealed because as found in (i) once put into force it cannot be repealed by any later Parliament, its provisions can merely be brought forward into current legislation, because a later Parliament cannot derogate from its forefathers legislation.

THIS TREATY IS BETWEEN **JINGKI**, SOVEREIGN QUEEN OF **GONDWANA LAND** AND **TURIKATUKU III GUMADA**, SOVEREIGN QUEEN OF **PARMATA O BALUDARRI RANGIHOU SOVEREIGN NATION AND EMBASSY AND JAPANANGKA**, ANCIENT CLAN ELDER OF TRIBAL SOVEREIGN NATIONS OF **GONDWANA LAND** AND **HOORI HARIHONA-PAERATA**, TRIBAL ELDER OF **PATU KORAHA TRIBAL SOVEREIGN NATION AOTEAROA, JUSTICE OF THE PEACE [THEIR PROGENY]**, BEING THE SAID GUARDIANS AND KNOWLEDGE KEEPERS OF THESE SAID SACRED LANDS, RETAINING AND RESERVING ALL RIGHTS TO THE INTERPRETATION OF THIS TREATY.

THIS TREATY IS PERTAINING TO ALL LANDS STATED IN THE NOTICE OF INTERNATIONAL JURISDICTION DATED 8TH SEPTEMBER 2014 BUT NOT LIMITED TO **RANGIHOU RESERVE, 1A MORTON STREET, 2 MORTON STREET AND BALUDARRI WETLANDS PARRAMATTA NSW 2150** [COMMONLY KNOWN BUT INCORRECTLY IDENTIFIED] WHICH ARE RARE NATIONAL HISTORICAL BURIAL AND SACRED SITES OF SIGNIFICANCE. THESE SAID LANDS ARE SACRED BURIAL SITES DUE TO **MASSACRES** DATING BACK TO **1795**; THE DEATH OF SONS AND DAUGHTERS OF MAORI NGA PUHI CHIEFS; THE DEATH OF **ORIGINEE CHIEF BALUDARRI** AND THE FACT THAT THESE LANDS WERE GIFTED TO ONLY **NGA PUHI MAORI CHIEFS**, NAMELY **PARETONGA, TE RUKI KAWITI, HONGI HIKA, RUATARA, KOROKORO, TE PAHI, WAIKATO, PATUONE** DATING BACK TO **1788** BY THE **DARUG TRIBE**, LAND THAT IS NOW UNDER INTERNATIONAL JURISDICTION SANCTIONED BY **TURIKATUKU III GUMADA, PARMATA O BALUDARRI RANGIHOU SOVEREIGN NATION AND JINGKI, ANCESTRAL ORIGINEE GRANDMOTHER SKIN LORES; MORTUARY LAW.**

THIS TREATY IS TO PROTECT THE TRADITIONAL LORES AND CUSTOMS OF THE **ANCESTRAL ORIGINEE GRANDMOTHER SKIN LORE'S** OF CREATION AND FERTILITY - **SPIRAL OF BIRTH, DEATH AND REBIRTH, SACRED LANDS, WATERWAYS AND ANCESTRAL REMAINS OF THE DARUG ORIGINEES AND MAORI CHILDREN OF MAORI NGA PUHI CHIEFS BURIED WITHIN THE SAID LANDS UNDER INTERNATIONAL JURISDICTION.**

THE RIGHT AND PRIVILEGE IS GRANTED TO **TURIKATUKU III GUMADA** AND HER PROGENY AND OF **PARMATA O BALUDARRI RANGIHOU SOVEREIGN NATION** AS THE TRUE **NGA PUHI AND DARUG BLOODLINE, SOVEREIGN GUARDIAN AND KNOWLEDGE KEEPER OF THESE SAID LANDS TO CURATE THE MASSACRE AND BURIAL SITES OVER AND WITHIN THE RANGIHOU AND BALUDARRI SACRED LANDS UNDER INTERNATIONAL JURISDICTION.**

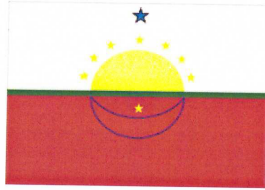

Dear Sir, Dear Judge; under SECT 6 of the British "Act to Constitute the Commonwealth of Australia Act 1900 (UK)", states: "*The Commonwealth" shall mean the Commonwealth of Australia as established under this Act. We do by these presents hereby constitute, order and declare immediately after public reading the Embassy of Paremata Sovereign Nation State, Gondwana Land, Australia avails itself of the

opportunity to maintain foreign relations with Australia, Aotearoa New Zealand and other Sovereign Nations of Gondwana Land and the world, assurances of the highest consideration. The Embassy of Paremata Sovereign Nation State, Gondwana Land, Australia presents its compliments and honor through discussions between officials of Australia, Aotearoa New Zealand and other Sovereign Nations of Gondwana Land and the world to ensure the safety of Sovereigns, Māori, Originee and PSNation Residents.

4. SOVEREIGN MONARCHS, THE KINGS AND QUEENS

We do by these presents hereby constitute and declare the restoration of the Kings and Queens (Ariki) whom shall preside as Sovereign Monarchs and Sovereign Head of State in their collective capacity, the Highest Authority, in accord and satisfaction with the Ariki to their proper order in and throughout all of Paremata Sovereign Nation State and Embassy, Gondwana Land, Australia. The Sovereign Monarchs shall be known as **TE UI ARIKI O PAREMATA TINO RANGATIRATANGA WHENUA GONDWANA**, THE HEREDITARY KINGS AND QUEENS OF PAREMATA SOVEREIGN NATION STATE GONDWANA LAND, AUSTRALIA.

5. SOVEREIGN QUEEN, SOVEREIGN HEAD OF STATE 2018

We do by these presents hereby constitute Sovereign Queen Turikatuku III Alexander herein named the Sovereign Head of State of Paremata Sovereign Nation State Gondwana Land, Australia 2018.

6. SUCCESSION TO THE THRONE

We do by these presents hereby constitute that Succession to the throne, opened by death or abdication, takes place in the direct and legitimate descent of the reigning Sovereign Monarch, in order of primogeniture, with the approval of the Privy Council. In the absence of direct and legitimate descendants, the succession operates for the benefit of brothers and sisters of the reigning Sovereign Monarch and their direct legitimate descendants in order of primogeniture. If the Heir who would be called to ascend the throne under the preceding paragraphs died or withdrew from the succession before the opening of succession, devolution takes place in favour of her/his own direct and legitimate descendants in order of primogeniture. If the application of the paragraphs above does not fill the vacancy of the throne, the succession takes place in favour of collateral appointed by the Privy Council and the Sovereign's powers are temporarily exercised by the Privy Council until such appointment is made. Succession to the Throne can only take place for the benefit of an individual having sovereignty within the Paremata Sovereign Nation State the day of the opening of succession.

7. SOVEREIGN HEAD OF STATE IN THEIR COLLECTIVE CAPACITY

We do by these presents hereby constitute and declare that **TE UI ARIKI O PAREMATA TINO RANGATIRATANGA WHENUA GONDWANA** shall preside as the Sovereign Head of State in their collective capacity the Highest Authority in and throughout Paremata Sovereign Nation State Gondwana Land, as Constituted.

8. SOVEREIGN HEAD OF STATE AUTHORITY

We do by these presents hereby constitute and declare that the Sovereign Head of State exercise their Sovereign authority in accordance with the provisions of the Constitution and the Laws of Paremata Sovereign Nation State Gondwana Land Australia.

9. SOVEREIGN HEAD OF STATE REPRESENTATION

We do by these presents hereby constitute and declare that the Sovereign Head of State and the Embassy represent the Paremata Sovereign Nation State in its relations with Australian and Foreign States.

10. SOVEREIGN HEAD OF STATE RATIFICATION OF TREATIES AND AGREEMENTS

We do by these presents hereby constitute and declare that the Sovereign Head of State signs and ratifies International Treaties and Agreements in consultation with the Embassy and reports through the Minister of State to the Parliament.

The following must be ratified by supporting legislation

- a. Treaties and International Agreements affecting Constitution;
- b. Treaties and International Agreements whose ratification entails the modification of existing lawful measures;
- c. Treaties and International Agreements whose execution have a budgetary expense not foreseen in the current Budget.

11. SOVEREIGN HEAD OF STATE RIGHTS OF PARDON

We do by these presents hereby constitute and declare that in consultation with the Embassy, the Sovereign Head of State exercises the rights of pardon, amnesty, naturalization and reinstatement of nationality.

12. SOVEREIGN HEAD OF STATE RIGHT TO CONFER LETTERS PATENT

We do by these presents hereby constitute and declare that the Sovereign Head of State have the right to confer Letters Patent, as he/she thinks fit. We hereby reserve to Ourselves, Our heirs and our successors, full rights, privileges, powers and authority from time to time to revoke, alter, add to, or amend these Our Letters Patent 2018 as to Us or them shall meet.

13. SOVEREIGN HEAD OF STATE RIGHTS TO CONFER ORDERS AND ISSUE TITLES

We do by these presents hereby constitute and declare that the Sovereign Head of State have the right to confer Orders, issue Titles and other distinctions on any sovereign as he/she thinks fit.

14. SOVEREIGN HEAD OF STATE TO MAKE CIVIL AND MILITARY APPOINTMENTS

We do by these presents hereby constitute and declare that the Sovereign Head of State may make Civil and Military appointments subject to this Letters Patent 2018.

15. SOVEREIGN HEAD OF STATE AGE OF MAJORITY

We do by these presents hereby constitute for the exercise of Sovereign Head of State power, the age of majority is fixed at eighteen. The organization and conditions of exercise of a Regency during the minority of the Sovereign or in the case of his inability to perform his/her duties are imposed by the Statutes of the Sovereign Monarchs family and exercised by the Privy Council acting as a Council of Regency.

16. SOVEREIGN MONARCHS POSSESSIONS

We do by these presents hereby constitute that the Crown's possessions are inalienable and imprescriptible. The Crown's possessions covered by this article are governed by the Statutes of the Royal Family.

17. SOVEREIGN HEAD OF STATES ROYAL DECREE AND LETTERS PATENT

We do by these presents hereby constitute and declare that the Royal Decrees and Letters Patent are formulated by the Privy Council and are presented to the Sovereign Head of State with the reasons for them under the signature of the President. They only become enforceable when signed by Sovereign Head of State. Matters relative to:

- a. competence of the Management of Judicial Services;
- b. dissolution of the Parliament;
- c. conferring awards that are the prerogative of the Sovereign;
- d. concerning appointment of;
 - i. Members of the Sovereign House,
 - ii. Members of the Diplomatic and Consular Corps,
 - iii. The President,
 - iv. The Minister of State,
 - v. Ministers of Government and the assimilated civil servants,
 - vi. Military Leaders of the Armed Forces, and
 - vii. Magistrates of the Judiciary;

18. ROYAL DECREES

We do by these presents hereby constitute and declare that Royal Decrees that are deliberated in the Cabinet and signed by the Minister of State and the President and passed on to the Sovereign Head of State within twenty-four hours of their signature and become enforceable only after signed by the Sovereign Head of State. The Sovereign Head of State *may* delegate his/her signature for some Decrees or some categories of Decrees to the Minister of State. These are enforceable as soon as they are signed. The Sovereign Head of State delivers the necessary Royal Decrees for the execution of Laws and for the application of Treaties or International Agreements.

19. ORDER THAT THE GOVERNOR GENERAL, THE CEO, MAYOR, DIRECTORS OF PARRAMATTA CITY COUNCIL AND THE GOVERNMENT OF AUSTRALIA TO CEASE AND DESIST AND STAND DOWN IN OUR REALM PSNS INC, NOW CONSTITUTED AS PAREMATA SOVEREIGN NATION STATE AND EMBASSY GONDWANA LAND, AUSTRALIA,

We do by these presents hereby constitute and order Rt Hon Malcolm Turnbull, his Cabinet Ministers, The Queen of Australia, The CEO of Parramatta City Council, the Mayor, the Directors, its agents and The Government of Australia to Cease and Desist all governance activities and to Stand Down forthwith in Our **REALM PSNS INC**. The Government of Australia are in Breach and Default and as such, All Privileges, Rights, Powers and Authorities to Govern in Our **REALM PSNS INC** and are hereby Revoked and withdrawn forthwith, as at the date of signing of these Our Letters Patent 2018 enacted. Any and all business, contracts and agreements entered into by The Government of Australia, Parramatta City Council, and any derivative or derivation of Corporation names thereof, with any individual, entity, corporation,

agent, private contractor, private company or governments of any and all foreign jurisdictions are hereby Revoked henceforth and forever.

20. POWER RESERVED TO THE QUEENS TO REVOKE, ALTER, ADD TO, OR AMEND THE PRESENT LETTERS PATENT 2018,

And We do hereby reserve to Ourselves, Our heirs and Our successors, full rights, privileges, powers and authority from time to time to revoke, alter, add to, or amend these Our Letters Patent 2018 as to Us or them shall meet.

21. PRESENT LETTERS PATENT 2018 TO HAVE EFFECT AS LAW,

And We do further Constitute, Proclaim and Declare with all rights, powers and authority vested in The 'Ariki' The Queen, that these Our Letters Patent shall take effect as part of the Law of Paremata Sovereign Nation State Gondwana Land, Australia as at the date of signing of these Our Letters Patent 2018 enacted, In witness where we have caused the Great Seal of Turikatuku III and the Great Seal of Turikatuku II and Hongi Hika to be affixed to these presents in the eyes of IO Matua Kore [Supreme God] which We, have autographed hereafter with Our Regal Royal Hands.

22. THE PRIVY COUNCIL

We do by these presents hereby constitute a Four Member Privy Council and Upper House, to advise Us and Our Government of Paremata Sovereign Nation State Gondwana Land, Australia;

- a. The Four Members shall serve as Privy Council, and
- b. The Privy Council shall be presided over by Sovereign Head of State (1), President (1) , an Administrator (1) and a Secretary (1) selected in accord and satisfaction of **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana** in their collective capacity.

23. MEMBERSHIP TO THE PRIVY COUNCIL

We do by these presents hereby constitute that the Privy Council shall consist of those individuals who having been appointed to the Privy Council from among individuals eligible for appointment under the Constitution Act 2018 are for the time being Our responsible advisers, and;

- a. The Privy Council shall sit as the Upper House over and above Our Government of Paremata Sovereign Nation State and the Parliament of Paremata Sovereign Nation Sate; and shall have the responsibility to oversee and vet all Bills passed by and through the Lower House 'Parliament'.
- b. The Privy Council shall in Council Assembled with the Sovereign Head of State;
 - i. Ratify any Bill(s) passed in the Lower House that are for the benefit and welfare of the People, and the economy of Paremata Sovereign Nation State, and or
 - ii. Revoke and Bill(s) that are not considered to be for the benefit and welfare of the People and the economy of Paremata Sovereign Nation State Gondwana Land Australia.

24. APPOINTMENT TO THE PRIVY COUNCIL

We do by these presents hereby constitute that the Privy Council shall at the end of each term appoint a new Council. Existing members are eligible for reappointment. The holders of the Offices of Minister of State or Minister of the Government are excluded from being a member of

the Privy Council.

25. PRIVY COUNCIL MEETINGS

We do by these presents hereby constitute that the Privy Council shall meet at least twice a year on the summons of the Sovereign Head of State. The Sovereign Head of State can summon the Privy Council at anytime they consider it necessary, either of their own initiative, or upon the suggestion of the President of the Privy Council.

26. PRIVY COUNCIL CONSULTED

We do by these presents hereby constitute that the Privy Council may advise and may be consulted by the Sovereign Head of State on questions regarding the interests of the Paremata Sovereign Nation State. The Privy Council must be consulted on the following subjects:

1. International Treaties,
2. dissolution of the Parliament,
3. demands for naturalization or reinstatement of sovereignty,
4. pardon and amnesty,
5. matters concerning the Royal Family.

27. PRIVY COUNCIL GENERAL INTERESTS

We do by these presents hereby constitute that the Ministers of Cabinet of the Government of Paremata Sovereign Nation State shall keep the President of the Privy Council fully informed concerning the general conduct of the Government of Our Nation, so far as they are responsible therefore, and shall furnish Our President with such information as he may require with respect to any particular matter relating to the Government of Our Nation.

28. PRIVY COUNCIL PRESIDENT

We do by these presents hereby constitute that the President of the Privy Council or if the holder of the Office is for any reason unable to perform any functions of Office, the next most senior Member shall serve as Our Acting President and take the oath herein, which such modifications as are necessary, shall be administered as and when required.

29. PRIVY COUNCIL DISSOLVING OF PARLIAMENT

We do by these presents hereby constitute that acting on the advice of the Privy Council the Sovereign Head of State may dissolve the Parliament with elections to be held 3 months from the day of dissolution.

30. EXECUTIVE COUNCIL

We do by these presents hereby constitute that the Executive Council shall consist of the Sovereign Head of State, the Privy Council, the Prime Minister and Cabinet Ministers, and individuals who having been appointed by the Privy Council.

31. EXECUTIVE COUNCIL POWER

We do by these presents hereby constitute that the Executive Council Power is vested in the Sovereign Head of State and is exercisable by the Privy Council and President as the Sovereign's representative.

Executive Council

1. Ariki (1)
2. President (1)
3. The Prime Minister (1)
4. The Minister of State (1)
5. Cabinet Ministers (5)
6. Administrator (1)
7. Secretary (1)

32. THE PRIME MINISTER

We do by these presents hereby constitute that the Prime Minister shall be selected by way of secret ballot by the Sovereign Head of State and the Privy Council. The Prime Minister shall be at liberty to select 5 Cabinet Ministers from those Members of Parliament elected to office by the voice of the people. The Prime Minister as the Sovereign Head of State's representative has responsibility for the executive services of Government. Deliberations of the Executive Government and Cabinet are to be recorded in a register and signed, following a vote, by the Members present. The register is to record the vote of each Member. The Register is to be transmitted within five days after a meeting, to the Sovereign Head of State, who can Veto the decision. Every Prime Minister shall, before assuming the functions of office take and subscribe before the President of the Privy Council the following sovereign oath:

I,.....being chosen and accepted as [Prime Minister] (or a Minister) and member of Cabinet swear by Almighty God that I will be faithful and bear true allegiance to, the Ariki of Paremata Sovereign Nation State and Embassy in their collective capacity as Sovereign Head of State and to the best of my judgement at all times when thereto required, freely give my counsel and advice to the [President of the Privy Council], for the good management of the affairs of Paremata Sovereign Nation State and that I will not directly or indirectly reveal such matters as shall be debated in Cabinet and committee and Executive Council and committed to my secrecy, but that I will in any such things be a true and faithful [Prime Minister] (or Minister). So help me God.

33. MINISTER OF STATE

We do by these presents hereby constitute that the Minister of State is Head of the Tribal Force.

34. PARLIAMENT ELECTED BY THE VOICE OF THE PEOPLE,

We do by these presents hereby constitute that the Parliament shall consist of the 26 Members of Parliament, individuals who having been elected to office by the voice of the people. Members of Parliament are elected for five year terms by direct universal suffrage and the electoral roll in conditions provided for by Legislation. Parliament consists of **26Members - Sovereign Originee/Māori 21 Seats, Other 5 Seats**. The Sovereigns/Originee/Māori of the land shall always hold the majority in the Parliament. The Parliament Committee - The Committee of the Parliament includes a President (1) and a Vice-President (1) elected each year by the Assembly from among Members. The legislation determines the functions which are incompatible with a people's election to the Parliament. Individuals of the Paremata Sovereign Nation of either sex are eligible for election to the Parliament, if they are over twenty five years old; are PSNation Residents and have lived in Our **REALM PSNS INC** for at least one year. Every

Member of Parliament shall, before assuming the functions of office take and subscribe before the President of the Privy Council the following sovereign oath:

I,..... swear by Almighty God that I will be faithful and bear true allegiance to, the Ariki of Paremata Sovereign Nation State and Embassy in their collective capacity as Sovereign Head of State, and their heirs and their successors, according to law and that I will justly and faithfully carry out my duties as a Member of Parliament of Paremata Sovereign Nation State. So help me God.

35. PARLIAMENT – THE LOWER HOUSE

We do by these presents hereby constitute that the Parliament shall sit as the Lower House of Our Government of Paremata Sovereign Nation State and shall have the responsibility to vet all Bills passed by and through the Lower House.

36. PARLIAMENT MEETINGS

We do by these presents hereby constitute that the Parliament shall meet each year in two ordinary sessions. The first session opens on the **6th day of February** and the second session opens on the **28th day of October**. The duration of any session cannot exceed three months. The closing of a session is pronounced by the President of the Privy Council. The Parliament meets in extraordinary session, either upon summons of the Sovereign Head of the State, or, at the request of at least two thirds of the Members, upon convocation from the President.

37. PARLIAMENT ORGANIZATION AND FUNCTIONING

We do by these presents hereby constitute that the organization and functioning of the Parliament are determined by Internal Regulation fixed by the Parliament. This Regulation must, before application, be submitted to the Privy Council, which pronounces on its Constitution and legislative legality. The Parliament shall, subject to this paragraph, determine its own agenda for each session. This is communicated to the Minister of State at least three days prior to the commencement of a session. At the request of the Government, one session at least must be dedicated to the discussion of proposed legislation submitted by the Sovereign Head of State. The agenda for special sessions convened by the Sovereign Head of State is to be given in the summons. Parliament's sessions are public. However the Parliament can decide, with a two-thirds majority of present Members, to sit behind closed doors. The report of public meetings is printed in the Official Newspaper.

38. PARLIAMENT COMMUNICATIONS

We do by these presents hereby constitute that the organization and the Sovereign Head of State communicates with the Parliament directly or by messages which are read by the Minister of State.

39. PARLIAMENT ATTENDEES

We do by these presents hereby constitute that the Minister of State and the Members of the Government may attend the Parliament's sessions. They must be heard when they ask to speak.

40. PARLIAMENT PASSED LEGISLATION

We do by these presents hereby constitute that the Passed Legislation implies an agreement between the Sovereign Head of State and the Parliament.

41. PARLIAMENT VOTING OF LEGISLATION

We do by these presents hereby constitute that consideration and voting of legislation belongs to the Parliament. The Sovereign Head of State approves proposed legislation by signing it. Such Bills are submitted by the Cabinet under the signature of the Minister of State. After the Sovereign Head of State approval, the Minister of State deposits them with the Parliament for consideration.

42. PARLIAMENT POWER TO INITIATE LEGISLATION

We do by these presents hereby constitute that the Sovereign Head of State along with the Parliament have the power to initiate Legislation. In case of a delay of six months from the reception date of a Bill proposal by the Minister of State, he/she must inform the Parliament of either the decision to transform, amend, delay, debate or withdraw the proposed Bill. The Parliament has the right to amend Bills before it. As such, it can propose additions, replacements or abolitions in a Bill but amendments can only have a direct link with the intent of the Bill. The final vote is taken on the bill with any amendments, unless the Government determines to withdraw the bill before the final vote.

43. PARLIAMENTARY ELECTION VOTING

We do by these presents hereby constitute that either sex are eligible to vote in elections as fixed by Legislation, if they are over twenty five years old; are PSNation Residents and have lived in Our **REALM PSNS INC** for at least one year. Every Member of Parliament shall, before assuming the functions of office take and subscribe before the Prime Minister of the Government the prescribed oath, which such modifications as are necessary, shall be administered as and when necessary.

44. PARLIAMENT CIVIL OR PENAL LIABILITY

We do by these presents hereby constitute that the Members of Parliament do not incur any civil or penal liability as a result of opinions expressed or votes taken by them in the exercise of their mandate. They may not, without the permission of the Parliament, be prosecuted or arrested during a session because of a criminal offence or civil action, except in cases of *flagrante delicto* (caught in the act of committing a criminal offence), murder, paedophilia or fraud.

45. ONE PARTY GOVERNMENT OF PAREMATA SOVEREIGN NATION STATE & EMBASSY GONDWANA LAND AUSTRALIA

We do by these presents hereby constitute that there shall be a One Party Government, namely The Government of Paremata Sovereign Nation State Gondwana Land Australia. All Members of Parliament working together for the best possible outcomes for the welfare and well being for Our sovereigns and for the betterment of Our economy and Our Nation.

46. THE ONE PARTY GOVERNMENT 'KOTAHITANGA'

We do by these presents hereby constitute that we must all work together as one '*Kotahitanga*', with one heart '*Aroha*', with one mind and place trust in God '*IO Matua Kore*' [Supreme God], exercise faith in spirit '*Te Wairua Tapu*', Our Kings and Queens '*Ariki*' that have gone before us and Our Ancestors '*Tupuna*' to guide us. It is time for our sovereign brothers and sisters to return to their homelands, to assist in managing our Ancestral Homeland Affairs for the benefit of Our People, the elderly, the widow and widower, the down trodden, the naked and the hungry, the homeless, the blind, the sick, the poor and the needy and those who are lowly in

heart, and the prisoner, to bear one another's burden, that there be no poor or stranger amongst us; for our children, our young single adults, our grandchildren, and future generations and those yet to be born.

47. ADMINISTRATOR OF THE GOVERNMENT OF PAREMATA SOVEREIGN NATION STATE

We do by these presents hereby constitute that the President of the Privy Council shall serve as Our Administrator of Government. Before entering on any of the duties of the office of Administrator of the Government, take the Oaths herein before directed to be taken by the Head of State, which Oaths, which such modifications as are necessary, shall be administered as and when necessary.

48. GOVERNMENT RESPONSIBILITIES

We do by these presents hereby constitute that the Government will be responsible for our own policies, consulting and co-operation in the common interests of the people in the promotion of international understanding and world peace. Affirming our core principles of consensus and common action, mutual respect, '*do no harm to another*', inclusiveness, transparency, accountability, legitimacy, and responsiveness. Our Ministers of the Executive Council and Parliament shall keep Our Administrator of Government fully informed concerning the general conduct of the Government and Ministers so far as they are responsible therefore and shall furnish Our Administrator with such information as he may request with respect to any particular matter relating to the Government and affairs of Paremata Sovereign Nation State.

49. GOVERNMENT PORTFOLIOS

We do by these presents hereby constitute that the Government Portfolios to be managed include:

- a. Embassy
- b. Finances - Treasury Bank Division
- c. Tribal Forces Division
- d. Justice Division - Courts
- e. Land Management Division
- f. Health, Wellness & Rehabilitation - Disability, Elderly, Youth Division
- g. Food and Water Division
- h. Education Division
- i. Infrastructure Division
- j. Transport Division
- k. Communications Division
- l. Agriculture Division
- m. Employment Division
- n. Trade Division
- o. Family & Community Division

50. PARLIAMENT CIVIL SERVANTS

We do by these presents hereby constitute that the fundamental obligations, rights and guarantees of civil servants, as well as their civil and criminal liability, are fixed by Law.

51. MUNICIPALITY COUNCILS

We do by these presents hereby constitute that Our **REALM PSNS INC** is administered by Our Municipality Councils composed of a Mayor and assistants, appointed by the Municipal Council from amongst its Members. PSNation Residents of the Paremata Sovereign Nation of either sex are eligible for election to a Municipality, if they are over twenty one years old and are PSNation Residents and have lived in Our **REALM PSNS INC** for at least one year. Every Member of Council shall, before assuming the functions of office take and subscribe before the Minister the prescribed oath, which such modifications as are necessary, shall be administered as and when necessary. Municipal Councils have at least five Members elected for four year terms by eligible voters resident in the municipality. Parliamentarians are eligible for membership of a Municipality.

52. MUNICIPALITY COUNCILS MEETINGS

We do by these presents hereby constitute that the Municipal Councils meet every three months in ordinary session and each session cannot exceed a fortnight. Extraordinary sessions may be held for definite objectives, at the request of or with the Minister of State's authorization. Municipal Councils meet in public on Municipal affairs. Its decisions are enforceable a fortnight after being communicated to the Minister of State, except when opposed by Royal Decree. Municipal Councils are chaired by a Mayor or, by in his/her absence, the Assistant Mayor.

53. MUNICIPALITY COUNCILS DISSOLVED

We do by these presents hereby constitute that Municipal Councils can be dissolved by Royal Decree after consultation with the Parliament. Where a Municipal Council is dissolved by Royal Decree or all the members of a Municipal Council are dismissed, the Minister of State will appoint an administrator to that Municipality until a new Council is elected. Such elections must take place within 3 months of dissolution or dismissal.

54. MUNICIPALITY COUNCILS BUDGET

We do by these presents hereby constitute that the Municipal Budget is provided by the budgetary allocation registered in the Annual Budget.

55. REQUIRE OUTSTANDING MĀORI AND ORIGINEE INHERITANCE MONEY FROM LANDS SECURED BY OUR CREDITORS STATUTORY DEMAND OF PAREMATA SOVEREIGN NATION STATE

We do by these presents hereby constitute and order All principals and agents of Parramatta City Council and the Australia Government holding Māori and Originee money and lands in Trust, Funds or Accounts or any derivative or derivation of account or trust or holding account to be returned to Paremata Sovereign Nation State, Sovereign Treasury Division. Outstanding notice of charge over Our **REALM PSNS INC**; including but not limited to Australia Lands and overseas lands in order to secure payment of debt to reasonable satisfaction of PAREMATA SOVEREIGN NATION STATE, damages and obligation, a debt now listed to the sum of ***AUD\$8,660,169,627,499.39**. (25% monthly interest), of which the debt demand matures 1st September 2018.

56. TREASURY AND BANK CONSTITUTED

We do by these presents hereby constitute a Sovereign Treasury and Bank of Paremata Sovereign Nation State, Gondwana Land for the benefit of our Sovereigns, PSNation Residents and Our Nation. There Shall be three (3) divisions of the Sovereign Treasury and Bank as follows:

1. The ***Sovereign Treasury Division*** shall be the Central Banking arm of Paremata Sovereign Nation State and shall have responsibility for monetary policy in relation to domestic and international affairs and banking, currency markets and inflationary measures and strategies; and
2. The ***Sovereign Bank of Paremata Sovereign Nation*** shall provide personal and business banking facilities on a day-to-day basis and shall operate in accord and satisfaction of international banking standards and practice; and
3. The ***International Trading Platform*** shall enable Our Traders to engage in international business on any and all stock exchanges throughout the world to generate:
 - a. Funding for Our PSNation Residents and Our Nation through Trading and Our Natural Resources above and below the Lands, and above and beneath the Seas and Commodities as the case may be; and
 - b. Every Originee and Māori (Man, Woman and Child) shall be beneficiaries of the Sovereign Treasury and Bank, and shall share in the profits thereof, as deemed appropriate.

57. TREASURY BANK

We do by these presents hereby constitute that we do require all sovereign monies recovered from the Parramatta City Council, the Australian Government and Corporations therein to be deposited in the ***Sovereign Bank of Paremata Sovereign Nation***.

58. FINANCIAL BUDGET PUBLIC EXPENDITURE

We do by these presents hereby constitute that the National Budget is to include all receipts and all Public Expenditures of the Paremata Sovereign Nation State and Government; that the Nations Budget is to represent the Economic and Financial Policy of the Paremata Sovereign Nation State and Government; that the expenses of Sovereign Head of State are fixed in the Budget and are taken by priority from the general receipts of the Budget; that any Budget surplus is to be transferred to a Sovereign Treasury Division. Any Budget deficit is to be drawn from the same account.

59. FINANCIAL BUDGET APPROVAL

We do by these presents hereby constitute that the Parliament must approve the Budget by a vote. Direct or indirect contribution to the budget can only be established by Legislation. Any Treaty or International Agreement having the effect of the establishment of such a contribution can be ratified only by legislation. Budget is to be presented to the Parliament before October 28th. The Budget is to be voted during the October session of the Parliament. The Budget is to be voted chapter by chapter. Once voted transfers from one chapter to another are forbidden, except in cases authorized by Legislation. The Budget allocates the amount which is to be at the disposal of the Municipality Councils for the incoming year. In the event of the Budget vote not having been held before December 31st, credits corresponding to requested services can be allocated by Royal Decree, and later confirmed by the Parliament.

60. RIGHTS AND FREEDOMS OF ALL PEOPLES

We do by these presents hereby constitute that everyone in Our **Realm PSNS INC** is entitled to all the rights and freedoms set forth in this Our Letters Patent without distinction of any kind, such as race, colour, sex, language, political or other opinion, national or social origin, property, birth or other status; that everyone has the right to life, liberty and security of individual; that no one shall be held in slavery or servitude; that slavery and the slave trade shall be prohibited

in all their forms; that all are equal before the law and are entitled without any discrimination to equal protection of the law; that all are entitled to equal protection against any discrimination in violation of this Letters Patent and against any incitement to such discrimination; that no one shall be subjected to arbitrary interference with his/her privacy, family, home or correspondence, or to attacks upon his/her honour and reputation; that everyone has the right to the protection of the law against such interference or attacks; that everyone has the right to freedom of movement and residence within Our **Realm PSNS INC**; and that everyone has the right to leave Our **Realm PSNS INC** and return to the Nation subject to Migration Laws 2018; that everyone has the right to freedom of thought and conscience; this right includes freedom to change his/her beliefs, to manifest his/her beliefs in teaching, practice, worship and observance so long as his/her religion or beliefs does not violate or incriminate the general principles of the Nations Letters Patent or that of the **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana**; that everyone has the right to freedom of opinion and expression: this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through internal media; that everyone in Our **Realm PSNS INC** has the right to freedom of peaceful assembly and association; that everyone in Our **Realm PSNS INC** shall be subject only to such limitations as are determined by law solely for the purpose of securing due recognition and respect for the rights and freedoms of others and of meeting the just requirements of morality, public order and the general welfare in Our **Realm PSNS INC**; everyone in Our **Realm PSNS INC** is entitled to a social order in which the rights and freedoms set forth in this Letters Patent can be fully realised and that nothing in this Letters Patent 2018 may be interpreted as implying for any individual any right to engage in any activity or to perform any act aimed at the destruction of any of the rights and freedoms of others or of Our **Realm PSNS INC** set forth herein.

61. MARRIAGE

We do by these presents hereby constitute that everyone of full age, without any limitation due to race, sex and nationality, have the right to marry and to found a family. Everyone is entitled to equal rights as to marriage, during marriage and at its dissolution.

62. PRIVACY RIGHTS OF ALL PEOPLES

We do by these presents hereby constitute that an individual's normal place of domicile is inviolate and no search can take place except where provided for by Law; that everyone has the right to privacy in their family life and correspondence, unless they breach Sovereign Rights and Dignity; that nobody can be deprived of his property except for public utility, but only then when legally notified and for just compensation; that All people in Our **Realm PSNS INC** have the right to peaceful assembly, without weapons, in accordance with the laws that regulate the exercise of this right without subjecting it to prior authorization. This freedom does not extend to outdoor gatherings, which remain subject to tribal force regulation; and that freedom of association is guaranteed under the Laws which regulate it.

63. LAND MANAGEMENT – ALLODIAL PROPERTY

We do by these presents hereby constitute and order that the subsurface lands in, above and below of Our **Realm PSNS INC** is the allodial property of **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana** except where alienated to the Public or State Domain.

64. LAND MANAGEMENT – HOME OWNERS WHO WANT TO LIVE IN PSNS

We do by these presents hereby constitute and order that all current home owners who live in Parramatta and choose to stay in Our **REALM PSNS INC**, that only and in accord and satisfaction of debt being paid through the Creditors Statutory Demand Ref:pbrsvsd0003 8th August 2018 and LETTERS PATENT 2018 enacted that;

- a. Mortgage will be paid in full.
- b. All home owners living in the Realm will be accepted under Our Migration Laws as a PSNation Resident.
- c. Title to house/building asset issued to home owner.
- d. Rental Lease Land *variable rate* per sqm pw. Increase 2.5% CPI yearly (cannot be sold or traded).
- e. Home owner has option to sell house/building asset only with first option to sell to PSNS.
- f. Home owner has option to rent house/building asset only to a PSNation Resident.
- g. Home owner has option to leave with revocation of PSNation Resident status.
- h. Free water pipes rental, waste management, electricity supply, Gas supply, internet.

65. LAND MANAGEMENT – HOME OWNERS WHO WANT TO LEAVE PSNS

We do by these presents hereby constitute and order that all current home owners who live in Parramatta and choose to leave Our **REALM PSNS INC**, that only and in accord and satisfaction of debt being paid through the Creditors Statutory Demand Ref:pbrsvsd0003 8th August 2018 and LETTERS PATENT 2018 enacted that;

- a. Parramatta Sovereign Nation State reserve the right to first option of purchase for the house and/or building asset at current market value upon proof of purchase.
- b. Home owner can remove the house and/or building asset from the land at own cost.
- c. Compensation will be paid for land at current market value, paid in full.
- d. If house/building asset is left unattended for 30 days without a Land Lease it will be seized and become the property of Parramatta Sovereign Nation State.
- e. All persons leaving Our **REALM OF PSNS** they refuse the right to obtain PSNation Residency.

66. LAND MANAGEMENT – HOME OWNERS WHO DO NOT LIVE IN PSNS BUT WISH TO RETURN

We do by these presents hereby constitute and order that all current home owners who do not live in Parramatta and wish to return to Our **Realm PSNS INC**

- a. All persons not living in **REALM PSNS INC** must apply under Our Migration Laws to get 'PSNation Resident' status.
- b. All persons must wait for a PSNation Resident to leave before they can be accepted. Home Owners you will be given priority. All non-residents must be accepted under Migration Laws of Parramatta Sovereign Nation State.

67. LAND MANAGEMENT – RENTERS WHO WANT TO LIVE IN PSNS

We do by these presents hereby constitute and order that all PSNation Residents who are renting in Parramatta who choose to stay in Our **Realm PSNS INC**

- a. Home owners in must reserve the right to first option of renting the house and/or building asset for a term no less than 12months;
- b. Rental Lease for Residential Land *variable rate* per sqm pw (House 1-10 years old);
- c. Rental Lease for Residential House *variable rate* per sqm pw (House 11-20 years old);
- d. Rental Lease for Residential House *variable rate* per sqm pw (House 21-50 years old);
- e. Rental Lease for Residential House *variable rate* per sqm pw (House 51 years and over);
- f. Increase 2.5% CPI yearly for House and Land

68. LAND MANAGEMENT – NON RESIDENTS WHO WANT TO RENT AND LIVE IN PSNS

We do by these presents hereby constitute and order all Non-Residents who want to rent and live in PSNS

- a. All non-residents not living in Our Realm must apply under our migration laws to get 'PSNation Resident' status.
- b. They must wait for a PSNation Resident to leave before they can be accepted. They must be accepted under Migration Laws of PSNS.
- c. Priority is always given to Home Owners, Māori, Originee, whanaunga, and immediate family.
- d. They can only purchase a house/building if they have PSN Residency.

69. LAND MANAGEMENT – LAND LEASES

We do by these presents hereby constitute and order that upon Letters Patent 2018 being enacted and upon confirming PSNation Resident Status, residents are required to undertake application request for a **LAND LEASE** for tenancy for the said occupied lands, through the Land Court of PAREMATA SOVEREIGN NATION STATE, forthwith. Be it known that LAND LEASES cannot be sold or traded. All negotiations for Land Leases remain the sole function of the Land Court of PAREMATA SOVEREIGN NATION STATE.

- a. Lease for Residential Land *variable rate* per sqm pw. Increase 2.5% CPI yearly
- b. Lease for Church Land *variable rate* per sqm pw. Increase 5% CPI yearly
- c. Lease for Small Business/Office Floor Space - *variable rate* per sqm pw. Increase 7.5% CPI yearly
- d. Lease for Large Business/Office Floor Space - *variable rate* per sqm pw. Increase 10% CPI yearly
- e. Lease for Industrial Land *variable rate* per sqm pw. Increase 12.5% CPI yearly
- f. Lease for Government Floor Space - *variable rate* per sqm pw. Increase 15% CPI yearly

70. LAND MANAGEMENT – GARDENS

We do by these presents hereby constitute and order that all PSNation Residents that it is a mandatory requirement of the Land Court of PAREMATA SOVEREIGN NATION STATE to grow fruit and vegetables on all nature strips and backyard gardens, maintaining all gardens at all times to a high standard and in accordance with Land Court standards.

71. LAND MANAGEMENT – RIGHT TO HOUSE, BUILDINGS AND ASSETS

We do by these presents hereby constitute that everyone in Paremata Sovereign Nation has the right to own, sell or lease any and all homes, buildings and assets. No one in Paremata Sovereign Nation shall be arbitrarily deprived of his buildings or assets. A land lease must be in order at all times, however if a land lease has expired or ceased the owner must re-lease immediately or remove the buildings and assets from the land within the specified time or as advised by the Land Court. All surface lands shall be subject only to land leases or concessions in accordance with the Laws of the Land Court PAREMATA SOVEREIGN NATION STATE.

72. LAND MANAGEMENT - PUBLIC AND STATE DOMAINS

We do by these presents hereby constitute that the Law Court regulates Public and State Domain possessions. The Public Domain is inalienable and imprescriptible. The deregistration of a Public or State Domain possession can only be achieved by the application of legislation.

73. CLASS ACTION PROCEEDINGS AGAINST AUSTRALIAN GOVERNMENT

We do by these presents hereby constitute and order that in the case that the Creditors Statutory Demand Ref:pbrsvsd0003 8th August 2018 is **not paid or satisfied**, that all home owners are hereby advised to **commence class action proceedings** against the Australian Government for the illegal sale of title [piece of paper] and land [never their legal possession] whereby they have never had or held absolute title in order to vest title to or in another.

74. EMPLOYMENT

We do by these presents hereby constitute that Paremata Sovereign Nation State & Embassy will seek to empower all PSNation Residents to their respective positions of skill and expertise to work at turning Our **Realm PSNS INC** into a place where all peoples can live in peace, love and harmony, collectively, creatively and with full responsibility. Everyone in Our **Realm PSNS INC** has the right to work, to free choice of employment, to just and favourable conditions of work.

75. EMPLOYMENT WAGE STANDARD

We do by these presents hereby constitute that the Minimum wage shall be set at AUD\$20 ph - 8hr day, Time and a half overtime 2hrs thereafter, Double Time Rates for every hour thereafter, Saturday time and half for first 2 hours, double time for every hour thereafter, Sunday shall be paid at Double Time. Public Holiday shall be paid at Double Time; and everyone no one shall pay Income Tax for the duration of their employment; and that everyone in Our **Realm PSNS INC**, without any discrimination, has the right to equal pay or energy exchange, barter, for equal work, and that everyone has the right to rest and leisure, including reasonable limitation of working hours and periodic holidays with pay or energy exchange. Freedom to work is guaranteed and is regulated by legislation. Priority is afforded to PSNation Residents for accession to public and private employment.

76. FAMILY HEALTH AND WELLNESS

We do by these presents hereby constitute that everyone in Our **Realm PSNS INC** has the right to a standard of living adequate for the health and well-being of himself/herself and of family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his or her control. All PSNation Residents in Our **Realm PSNS INC** must provide for themselves either individually or in association for their social welfare and old age pension.

77. FAMILY – MOTHER AND CHILD

We do by these presents hereby constitute that Motherhood and childhood are entitled to special care and assistance. All children in Our **Realm PSNS INC** whether born in or out of wedlock, shall enjoy the same social protection.

78. TRUE POTENTIAL LEARNING AND EDUCATION

We do by these presents hereby constitute that everyone in Our **Realm PSNS INC** has the right to True Potential Learning and Education. The education shall be free, at least in the elementary and fundamental stages. Elementary education shall be compulsory. Technical and professional education shall be made generally available and higher education shall be equally accessible to all on the basis of merit. All education shall be directed to the full development of the individual and to the strengthening of respect for people, family, nature, the land, the arts, music, science, customs, traditions, values, language, rights and fundamental freedoms. It shall target nature, regeneration, cleansing of the lands, research, natural remedies, holistic medicines and scientific

research. It shall promote understanding, tolerance and friendship among all nations, and shall further the activities of the Paremata Sovereign Nation in the furtherance of world peace. All Parents have a prior right to choose the kind or type of True Potential Learning and Education that shall be given to their children. All Parents have the duty to educate their children until maturity and give them every chance to integrate themselves into the World. Paremata Sovereign Nation State will work closely with the elderly to harness their skill and abilities as the 'knowledge keeps and teachers' for our children and future generations.

79. CULTURE AND ART

We do by these presents hereby constitute that everyone in Our **Realm PSNS INC** has the right freely to participate in the cultural life of the community, to enjoy the arts and to share in scientific advancement and its benefits. Everyone in Our **Realm PSNS INC** has the right to the protection of the moral and material interests resulting from any scientific, literary or artistic production of which he is the author.

80. MIGRATION LAWS

We do by these presents hereby constitute and order that All persons not living in **REALM PSNS INC** must apply under Our Migration Laws to get 'PSNation Resident' status

- a. All persons must wait for a PSNation Resident to LEAVE before they can be accepted and ENTER.
- b. Originee, Māori, Home Owners and immediate family will be given priority.

81. NATION FLAG IN PAREMATA SOVEREIGN NATION STATE

We do by these presents hereby constitute and declare that the NATION FLAG of Paremata Sovereign Nation State is the International Protectorate for all countries in the Pacific Ocean, the 1834 United Tribes of New Zealand Flag, chosen by the 25 Māori Chiefs at Waitangi, also sent to London for the King William IV approval, published in the New South Wales Gazette 17th August 1835. In October 1835, 35 Māori Chiefs and heads of tribes thanked the King for his acknowledgement of their flag in Te Tiriti o Waitangi 1835. The flag significant of Maori Sovereignty protected by whakapapa; Nga Ariki me nga Rangatira; Native Defence and Nga Hapu katou.



82. NATION SEAL OF PAREMATA SOVEREIGN NATION STATE & EMBASSY

We do by these presents hereby constitute and declare that the NATION SEAL is that of Tino Rangatiratanga Sovereign Queen Turikatuku III, the spiritual bearers of Paremata Sovereign Nation State. All other government and parliamentary seals or symbols of the state are determined under the authority of Sovereign Queen Turikatuku III or her heirs and successors in law and are as published by Parliament.



83. NATION SEAL OF THE LAW COURTS

We do by these presents hereby constitute and declare that the LAW COURTS SEAL is that of Tino Rangatiratanga Ariki Hongi Hika and Turikatuku II, the spiritual bearers of Paremata Sovereign Nation State. All other government and parliamentary seals or symbols of the state are determined under the authority of Sovereign Queen Turikatuku III or her



heirs and successors in law and are as published by Parliament.

84. LANGUAGE

We do by these presents hereby constitute that English is the official language of the Paremata Sovereign Nation State with Originee and Māori as second and third languages.

85. TRIBAL FORCES

We do by these presents hereby constitute and empower the Tribal Force to maintain law, order, security, safety, protection, in and throughout Our **Realm PSNS INC.** There shall be a Tribal Forces Commissioner appointed to accord and satisfaction of the Sovereign Head of State and the Executive Council;

1. The Tribal Forces Commissioner shall be invested with all rights, powers and authority necessary to maintain law, order, security, safety and protection, and
2. Shall be provided with the necessary resources to enable proper and effective law and order.
3. The Tribal Forces shall be transferred into restorative units to build infrastructure, shelter, replant trees and forests, clean waters and purify the atmosphere.

86. ROYAL NAVY

We do by these presents hereby constitute and empower the Royal Navy of Our **Realm PSNS INC.** To maintain surveillance and Border Security of Our Economic Zone; for support of the PSNation Residents while on the seas; for support of other Sovereign Nations; for support of outer islands; and to provide immediate emergency response at sea as deemed necessary. There shall be a Fleet of Patrol boats and Destroyers, with sufficient armoury as deemed necessary and appropriate to provide protection of our Borders and for our Sovereigns, PSNation Residents and Nation. And thus provide employment and career prospects for our young men and woman.

87. ROYAL AIR FORCE

We do by these presents hereby constitute and empower the Royal Air Force of Our **Realm PSNS INC.** To maintain surveillance and Border Security of Our Economic Zone; for support of the PSNation Residents while on the land; for support of other Sovereign Nations; for support of outer islands; and to provide immediate emergency Air response as deemed necessary. There shall be a Squadron of combat Jet Aircraft, together with a Transport Squadron, with sufficient armoury as deemed necessary and appropriate to provide protection of our Borders and for our Sovereigns, PSNation Residents and Nation. And thus provide employment and career prospects for our young men and woman.

88. ROYAL ARMY

We do by these presents hereby constitute and empower the Royal Army of Our **Realm PSNS INC.** There shall be three Divisions (1) Special Army Services (SAS) (2) Infantry (3) Army Reserves; disciplined and highly trained to respond to a range of situations in Our **Realm PSNS INC.**; for support of other Sovereign Nations; for support of outer islands; and to provided immediate emergency response as deemed necessary and appropriate to provide protection of our Borders and for our Sovereigns and Nation. And thus provide employment and career prospects for our young men and woman.

89. RIGHT TO TAKE UP ARMS

We do by these presents hereby constitute and empower Our PSNation Residents the Right to Take Up Arms in defence of **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana**, PSNation Residents in reclaiming, restoring and protecting our customs, traditions, rights, privileges, powers, authority, culture and the lands of our inheritance, as and when the need arises and agreed in Executive Council Assembled.

90. QUEENS COURT

We do by these presents hereby constitute and empower the Queens Court in Paremata Sovereign Nation State Gondwana Land. The Queens Court shall be the Highest Court in Our **Realm PSNS INC**;

- a. English, British, Foreign or European Judges and Lawyers from foreign countries shall have NO jurisdiction in Paremata Sovereign Nation State Courts, and
- b. The Highest Judges in Paremata Sovereign Nation State shall be **Te Ui Ariki O Paremata Tino Rangatiratanga Whenua Gondwana**.

91. PEOPLES COURT

We do by these presents hereby constitute and empower the Peoples Court in Our **Realm PSNS INC**. The Peoples Court shall be the Lower Court. English, British, Foreign or European Judges and Lawyers from foreign countries shall have NO jurisdiction in Our Peoples Court.

92. LAND COURT

We do by these presents hereby constitute and empower the Land Court in Our **Realm PSNS INC**. The Land Court Shall deal with all land matters, land leases directed to the Land Court from the Municipal Councils.

93. PREROGATIVE OF MERCY

We do by these presents hereby constitute, authorise and empower the Privy Council, in Our name and on Our behalf, to exercise the prerogative of mercy in and throughout Our **Realm PSNS INC** to any PSNation Resident that they see fit, convicted of any offence for which he may be tried in any court, a pardon, either free or subject to lawful conditions; or grant a respite, either indefinite or for a specified period, of the execution of any sentence passed on that PSNation Resident in any court.

94. FREEDOM AND SECURITY

We do by these presents hereby constitute that all PSNation Residents are guaranteed freedom and security. No one can be prosecuted except for breaches of violations and crimes before the Courts, as established under this Letters Patent 2018. Except in the case of *flagrante delicto*, no individual may be arrested except by a warrant issued by a Judge, such warrant must be served at the time of arrest or within twenty-four hours. Any detention must be preceded by an interrogation.

95. HUMAN RIGHTS AND DIGNITY

We do by these presents hereby constitute that No penalty except that established by law can be applied. Any law establishing a penalty must take into account Human Rights and Dignity and cannot be retrospective. Capital and Corporal Punishment are banned. No one in Our **Realm PSNS INC** shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment. Everyone in Our **Realm PSNS INC** has the right to recognition as an individual before

the law/lore.

96. FAIR RIGHT TO TRIAL

We do by these presents hereby constitute that everyone in Our **Realm PSNS INC** can defend his rights and interests and has the right to a fair trial. Everyone is entitled in full equality to a fair and public hearing by an independent and impartial tribunal under common law, in the determination of his/her rights and obligations and of any criminal charge against him/her. Everyone in Our **Realm PSNS INC** charged with a penal offence has the right to be presumed innocent until proven guilty according to common and tribal law in a trial at which he/she has had all the guarantees necessary for his/her defence. Everyone in Our **Realm PSNS INC** upon trial, lawfully fully charged with a crime or offence against another is required to meet with the delegates of the victim and/or family of the victim, face to face, so the victim and/or family of the victim can be fully heard, before the Peoples Court in the presence of the victims family elders.

97. INDIVIDUALS CONVICTED

We do by these presents hereby constitute that any individual that is convicted of a murder, paedophilia, extortion, fraud or crimes against the Head of State within the Paremata Sovereign Nation State will be subject to lawful conditions as the Queens Court may think fit to impose.

98. JUDICIAL POWER – ALL COURTS

We do by these presents hereby constitute that Judicial power is vested in the Sovereign Head of State who, by this present Letters Patent 2018, delegates this power to the Courts in Our **Realm PSNS INC**. Judicial power is exercised by the Queens Court, Peoples Court and Land Court as established under this Letters Patent 2018. Judicial Independence is guaranteed. The Jurisdiction, organization and functioning of the Courts and the Status of Judges is determined by Legislation.

99. JUDICIAL POWER - THE QUEENS COURT

We do by these presents hereby constitute that the Queens Court shall have jurisdiction, with such exceptions and subject to such regulations as the Parliament prescribes, to hear and determine appeals from all judgments, decrees, orders, and sentences: and the judgment of the Privy Court in all such cases shall be final and conclusive. The Queens Court deliberates either as a Full court of all Members, or as an Administrative Court of three Members. It sits and deliberates as a Full Court:

- a. On Constitution subjects;
- b. On conflicts of competence;
- c. In administrative matters on dismissal ordered by the President of the Privy Council or decided with the Administrative Court.
- d. It sits and deliberates in as an Administrative Court in all other cases.

100. THE REVISION OF THIS LETTERS PATENT 2018

We do by these presents hereby constitute that this Letters Patent 2018 cannot be suspended either in whole or in part. The total or partial revision of the present Letters Patent 2018 requires the agreement of both the Sovereign Head of State and the Privy Council.

101. FINAL AND TRANSITORY CAPACITIES

We do by these presents hereby constitute that all previous Letters Patent are abrogated as soon as this Letters Patent 2018 comes into effect at once. Elections of the Parliament and Municipal

Councils are to take place as soon as conditions imposed by the adoption of this Letters Patent 2018 are fulfilled and at the latest with no more than a three years delay. In the absence of the Parliament, Legislative and Executive power are exercised by the Sovereign Head of State alone. In absence of elected Members of the Parliament during this transitory period, Members named on the nomination of the Parliament are temporarily appointed by the Sovereign Head of State until the Parliament is in a position to present Candidates. The Laws and Regulations of Paremata Sovereign Nation State upon Independence Day 28th October 2013 with Laws and Royal Decrees are hereby activated and applicable.

102. ARTIFACTS, TAONGAS (TREASURES) AND HUMAN REMAINS

We do by these presents hereby constitute that all artefacts, taongas, treasures, human remains that belong to TE UI ARIKI O PAREMATA TIMO RANGATIRATANGA WHENUA GONDWANA THE HEREDITARY KINGS AND QUEENS OF PAREMATA SOVEREIGN NATION STATE GONDWANA LAND AUSTRALIA in Australia and New Zealand will be claimed and taongas, treasures and human remains returned to Paremata Sovereign Nation representatives and State.

103. INVITATION TO SOVEREIGN NATIONS IN AUSTRALIA AND AOTEAROA, NEW ZEALAND

We do by these presents cordially invite other Sovereign Nations in Australia and New Zealand to come together as one 'Kotahitanga' with humble hearts and love for one-for-another; and to lay aside our private animosities, and to consult the safety and welfare of our common nations and counties. To take our rightful place in the Governance of the Lands of our inheritance, our Homeland, Our Nation, Our Country and fulfil our responsibilities as guardians of the lands, assigned to us, assigned to our 'Tupuna' [Ancestors]and by 'IO Matua Kore' [Supreme God].

In witness whereof We have caused these Our Letters to be made patent, and for the greater testimony and validity thereof We have caused the Seal of Ariki Turikatuku III, the Seal of Ariki Hongi Hika and Turikatuku II to be affixed to these presents, which We have signed with Our Regal Hand. Given the 12th day of August in the Year of Our Lord IO Matua Kore Two Thousand and Sixteen.

Non-Combatant:	Not serving in a fighting capacity. (<i>Black's Law Dictionary 6th Edition</i>)
Non-contentious:	Not causing or likely to cause an argument. (<i>Google online dictionary</i>)
Literae Patentis regis on erunt vacuae:	A public grant from the sovereign to a subject, conferring the right to land, a franchise, a title, liberty, or some other endowment. The modern "patent" and more closely "letters

patent" derive from this term. (*Black's Law Dictionary 6th Edition*) **Regis on erunt vacuae** Letters patent of the King shall not be void, in this case the Queen. (*the cyclopedic dictionary of law*)

- Revocation:** An annulment, cancellation or reversal of an act or power. (*Black's Law Dictionary 6th Edition*)
- Rangihou:** Land Area in Parramatta close to New Zealand Street. A National place of high archaeological significance for Maori. Burial site for Maori and Originee.
- Baludarri:** Land Area in Parramatta close to Morton Street. A National place of high archaeological significance for Originee. Burial site for Originee. Massacre Site 1795.
- Kaitiaki:** Guardian
- Cessation:** the fact or process of ending or being brought to an end. (*Google online dictionary*)
- Pre-emption:** the purchase of goods or shares by one person or party before the opportunity is offered to others. (*Google online dictionary*)
- Alienate:** make (someone) feel isolated or estranged. (*Google online dictionary*)
- Acknowledgement:** acceptance of the truth or existence of something. (*Google online dictionary*)
- Annexation:** is the political transition of land from the control of one entity to another. It is also the incorporation of unclaimed land into a state's sovereignty, which is in most cases legitimate. (*Google online dictionary*)
- Appurtenant:** belonging; pertinent. (*Google online dictionary*)
- Derivative** The **derivative** of a function of a real variable measures the sensitivity to change of a quantity (a function value or dependent variable) which is determined by another quantity (the independent variable). **Derivatives** are a fundamental tool of calculus. (*Google online dictionary*)
- Revoke** officially cancel (a decree, decision, or promise). (*Google online dictionary*)
- Cestui Que Vie Act 1666**
An Act for Redresse of Inconveniencies by want of Proofoe of the Deceases of Persons beyond the Seas or absenting themselves, upon whose Lives Estates doe depend. (*Google online dictionary*)
- Cestui Que Trust** The **cestui que trust** is the person entitled to an equitable, as opposed to a legal, estate. Thus, if land is granted to the use of A in **trust** for B, A is **cestui que trust**, and B trustee, or use. (*Google online dictionary*)
- IO Matua Kore:** Supreme God (*Google online dictionary*)
- Atua:** ancestor with continuing influence, god, demon, supernatural being, deity, ghost, object of superstitious regard, strange being - although often translated as 'god' and now also used for the Christian God, this is a misconception of the real meaning. Many Māori trace their ancestry from atua in their whakapapa and they are regarded as ancestors with influence over particular domains. These atua also were a way of rationalising and perceiving the world. Normally invisible, atua may have visible representations. (*Maori dictionary*)
- Whanaunga:** relative, relation, kin, blood relation (*Maori Dictionary*)
- Whakapapa:** genealogy, lineage, descent (*Maori Dictionary*)

Hereditary:	Inheritance by law; title by descent; relating to heredity or inheritance. Transmitted or capable of being transmitted genetically from parent to offspring (<i>Google online dictionary</i>)
Native:	Someone born into one's native land (<i>Google online dictionary</i>)
Originee:	Otherwise known as Indigenous, Native, Tribal Aboriginal of Australia and New Zealand (<i>Google online dictionary</i>)
Proprietor:	means any person seized or possessed of any estate or interest in land, at law or in equity, in possession or expectancy (<i>Land Transfer Act 1952</i>)
Owner:	The person in whom is vested the ownership, dominion, or title of property; proprietor (<i>Black's Law Dictionary 6th Edition</i>)
Person:	legal entity, a thing, an artificial construct and not a living being "a means of proving a person's identity, especially in the form of official papers". Latin persona - actor's mask, character in a play, later human being.
Individual:	a single human being as distinct from a group (<i>Google online dictionary</i>)
Natural Person	a human being, naturally born, versus a legally generated juridical person. Also a natural person is any human being with legal capacity commencing from the time of birth. A living breathing human being.
Land:	<i>land</i> include sthe body and flesh, messuages (a dwelling house with outbuildings and land assigned to its use), tenements (a room or a set of rooms forming a separate residence within a house or block of flats), and hereditaments (is any kind of property that can be inherited), corporeal and incorporeal, of every kind and description, and every estate or interest therein, together with all paths, passages, ways, waters, watercourses, liberties, easements, and privileges thereunto appertaining, plantations, gardens, mines, minerals, and quarries, and all trees and timber thereon or there under lying or being, unless specially excepted(<i>Land Transfer Act 1952</i>).
Allodaryl:	Owners of allodial lands. Ownership of estates as large as a subject may have (<i>Black's Law Dictionary 6th Edition</i>)
Allodial:	Free; not holden of any lord or superior, owned without obligation of vassalage or fealty: the opposite of feudal (<i>Black's Law Dictionary 6th Edition</i>)
Revocation:	The recall of some power, authority, or thing granted, or a destroying or making void of some deed that had existence until the act of revocation made it void. It may be either general, of all acts and things done before; or special, to revoke particular things (<i>Black's Law Dictionary 2nd Edition</i>)
Sui Juris:	Of his/her own right; possessing full social and civil rights; not under any legal disability, or the power of another, or guardianship. Having capacity to manage one's own affairs; not under legal disability to act for one's self. (<i>Black's Law Dictionary 2nd Edition</i>)
Red Border:	The Red Border that surrounds the Letters Patent symbolises the 'Ariki' blood lines of TE UI ARIKI O PAREMATA TINO RANGATIRATANGA WHENUA GONDWANA, The Hereditary Queens of Paremata Sovereign Nation State, Gondwana Land, Australia. Originee symbolised by the Red outer lines. Maori symbolised by the inner Red line.
