The Crown of the Mauri Nation, successor to Te Tiriti o Waitangi/Treaty of Waitangi 1840 of Aotearoha/land mass of New Zealand address you today to uphold peace on our lands, for mana tangata(people), pakeha (british subjects) our suv'eran charters, nations, mana whenua (lands), tamariki (children) and our future;

The Crown of the Mauri Nation served the New Zealand Prime Minister with a Royal Decree Proclamation Judgment on the 22nd December 2021 in hand;

The Crown of the Mauri Nation announce that 21 days from delivery of the Royal Decree Proclamation Judgment has passed without a rebuttal in law;

The New Zealand Prime Minister, representative of HER MAJESTY THE QUEEN IN RIGHT OF NEW ZEALAND SEC CIK #0000216105 have failed to [re]spond/[re]but to the [o]rders, claims/[de]mands; this qualifies tacit-[a]dmission, which is consent, [a]ccepted-by-[e]quitable-[e]stoppel-by-[a]cquiescence;

The Crown of the Mauri Nation point to the following laws to qualify our jurisdiction on our paramount lands of Aotearoha [New Zealand] in international law;

- "Once JURISDICTION is challenged, it must be proven" Hagens vs. Lavine., 415 u.s. tee Note 3.
- "JURISDICTION can be challenged at any time, even on final determination." Basso vs. Utah Power & Light Co., 495 F. 2nd 906 at 910;
- "The law provides that once State and Federal jurisdiction has been challenged, it must be proven" Main vs. Thiboutot., 100 S Ct. 2502 (1980);

- “Where there is absence of proof of jurisdiction, all administrative and judicial proceedings are nullity, and confer no right, offer no protection, and afford no justification, and may be rejected upon strict collateral attack.” Thompson vs. Tolmie., 2 Pet. 157., 7 L. Ed. 381. Griffith vs. Frazier., 8 Cr. 9., 3 L. Ed. 471;

The Crown of the Mauri Nation hereby announce that no jurisdictional challenge to the Royal Decree Proclamation Judgment has been received; this qualifies tacit-[a]dmission, which is consent, [a]ccepted-by-[e]quitable-[e]stoppel-by-[a]cquiescence;

The Crown of the Mauri Nation hereby announce that no jurisdictional challenge to our unalienable rights to paramount lands, power and authority from the New Zealand Prime Minister, HER MAJESTY THE QUEEN IN RIGHT OF NEW ZEALAND SEC CIK#0000216105 has been received; this qualifies tacit-[a]dmission, which is consent, [a]ccepted-by-[e]quitable-[e]stoppel-by-[a]cquiescence;

The Crown of the Mauri Nation hereby protect, transfer & take full control of the lands, property and assets into Te Whakaruru Hau Aotearoha & Rangihou Trust (Pure Trust) Number/-RPP4463800094001989670600, effective immediately and mandated with Special Resolutions dated 11th January, passed in Te Whare Runanga [government], given the Crown Royal Assent and sealed with the Great Seal of the Crown of the Mauri Nation.

The Crown of the Mauri Nation gives final order to HER MAJESTY THE QUEEN IN RIGHT OF NEW ZEALAND SEC CIK#0000216105 to take your belongings and honorably leave our buildings, properties and paramount lands effective immediately.

The Crown of the Mauri Nation state that a dishonor of our Crown Royal Assent Orders will result in forced removal of your agents & family off our lands with the assistance of international security and intelligence.
