: ~4. The Principals of the Crown-of-the-Mauri-Nation now pass a Special [Re]solution that the following protectorates, constitution and act be upheld for our Royal-Decree-Proclamation-Judgment:

a) Standing-Orders/1843 in Council for the Protection of Native Sovereignty is our Declaration for the Dominion of New Zealand, of the Dominion of New Zealand of the Native Tribes and peoples of this land, is one of the three Sacred Covenants recognized by the Crown of England, King William IV. That Lord Stanely declared this country our "Dominion of God". The House of Lords 1843 Standing Orders in Council for the protection of the Native Sovereignty" has recognized this, has added weight to the He-W(h)hakatutanga-o-te-rangatiratanga-o-nu-tireni/~1835 written and live[ing] constitution;

b) He-W(h)hakatutanga-o-te-rangatiratanga-o-nu-tireni/~1835 Constitution is the only claim in written law to our Native Status to the Native Title, where we hold in written law the unextinguished Native Title to Na-Papatuanuku-Aotearoa, first people to the soil Papatuanuku[earth mother]. It proclaimed the Independence of the Dominion of Nu Tireni in rem whereby in 1835 the Grantors and Registered Proprietors consolidated their Hapuu Kingdom as "Crown Land", mirroring Local Government Trust Districts;

c) Pacific Islanders Protection Act 1875, section 7. Saving of rights of tribes.- Nothing herein or in any such Order in Council contained shall extend or be construed to extend to invest Her Majesty, her heirs and successors* with any claim or title whatsoever to dominion or sovereignty over any such islands or places as aforesaid, or to derogate from the rights of the tribes or people inhabiting such islands or places, or of chiefs or rulers thereof, to such sovereignty or dominion.
